## NEW JERSEY HIGHLANDS WATER PROTECTION AND PLANNING COUNCIL APPROVAL OF CONTRACTS TO DEVELOP OR UPDATE WATERSHED RESTORATION AND PROTECTION PLANS WITHIN THE NEW JERSEY HIGHLANDS REGION

**WHEREAS**, the Highlands Water Protection and Planning Act (Highlands Act), N.J.S.A. 13:20-1 et seq., has created a public body corporate and politic with corporate succession known as the Highlands Water Protection and Planning Council (Highlands Council); and

WHEREAS, the Highlands Council is tasked with implementing the Highlands Act; and

**WHEREAS**, section 6.g of the Highlands Act authorizes the Highlands Council to enter into any and all agreements or contracts to effectuate the purposes of the Highlands Act; and

**WHEREAS**, there are a number of goals in the Highlands Act that the Highlands Council is responsible for achieving, and the overarching goal is the protection of the Region's natural resources with an emphasis on restoration/protection of water resources; and

**WHEREAS**, to help meet this goal, the Highlands Council seeks to develop or update additional Watershed Restoration and Protection Plans within the Region; and

**WHEREAS**, the Highlands Council prepared a Request for Proposals (RFP) seeking multidisciplinary teams (Teams) to develop or update Watershed Restoration and Protection Plans for one or more subwatershed(s) within the Highlands Region, which can be used to apply for funding from the New Jersey Department of Environmental Protection (NJDEP) for Water Quality Restoration Grants under the federal 319(h) pass-through grants of the Federal Clean Water Act (CWA), as well as other funding sources; and

WHEREAS, the Highlands Council focus for this project is on protecting high quality subwatersheds as well as improving subwatersheds that are impaired due to any number of factors, including but not limited to point & non-point source pollution issues, harmful algal blooms (HABs), contamination for which total maximum daily loads (TMDLs) have been developed or are in need of development, contaminated sites, stormwater impacts, septic system failures, animal waste, agricultural practices, climate change and dams; and

**WHEREAS**, this project will ultimately identify methods for improving the watershed(s), including load reduction methods, septic system maintenance recommendations (if needed), green stormwater infrastructure implementation, stormwater facilities retrofit/rehabilitation projects, dam removal projects (if applicable), and best management practices within the identified subwatershed(s); and

WHEREAS, the RFP was released to the public on January 25, 2023, and four (4) Teams submitted proposals on or before the deadline of April 17, 2023; and

**WHEREAS**, after reviewing the proposals, staff selected three (3) Teams to participate in in-depth interviews to determine the extent of their expertise in all facets of watershed restoration and protection and their overall suitability to provide the services contemplated in the RFP; and

WHEREAS, Highlands Council staff recommends that the following teams are best suited to meet the needs articulated by the Highlands Council's RFP: 1) Princeton Hydro, LLC; and 2)

**WHEREAS**, Highlands Council staff further recommends that the Highlands Council authorize the Executive Director to enter into contracts with the aforementioned Teams to develop or update watershed restoration and protection plans.

**NOW, THEREFORE, BE IT RESOLVED** by the Highlands Council that the Executive Director, or their designee, is hereby authorized to enter into contracts with: Princeton Hydro, LLC, for an amount not to exceed \$334,915 and Engineering & Land Planning Associates, Inc., for an amount not to exceed \$41,000.
