
# Staff visit February 21, 2023

#### Objectives

- First-hand, on-the-ground observation
- Determine if activities align with approved Forest Stewardship Plan
- Determine impacts to Highlands resources.

#### Sites visited

Stand 18 Seed Tree, 2022/2023 Stand 9b Shelterwood Stand 8 Seed Tree Stand 18 Shelterwood Stand 18 Seed Tree, 2012/2013 Stand 7 Proposed site





### Stand 18 Seed Tree

**O years** post treatment

- No regeneration present yet.
- Significant volume of woody material left on site.





## Stand 9 Shelterwood

**1 year** post treatment

- Woody material left across site.
- Early stages of natural regeneration with native species observed.







### Stand 8 Seed Tree

3 years post treatment

 Natural regeneration of desired species observed.





### Stand 18 Shelterwood

8 years post treatment

- Natural regeneration of desired species observed.
- Some nonnative plant species observed.







## Stand 18 Seed Tree

**10 years** post treatment

 Sustained growth of natural regeneration observed.





#### Stand 7 Proposed site

Proposed for treatment fall/winter 23/24

• Sparce understory observed.





# **Summary of Findings**

- Activities align with those specified in Forest Stewardship Plan.
- Anticipated tree regeneration is occurring on multiple sites.
- No observed activities of concern related to Highlands resources.

### Highlands Council staff will continue to monitor.

# Chester Township Map Adjustment Request

- Request to accommodate an affordable housing proposal at the former Glenlora Nursing Home. Site is currently developed, but unused.
- 14.38-acre site currently divided between Protection Zone (7.58 acres), and the Existing Community Zone (6.8 acres).
- Request to move a portion of the on-site PZ to ECZ to allow for expansion of sewer service area.
- A public comment period was held March 2 through April 2, 2023. No comments were received.

Location Block 26.06, Lot 7 Chester Township, Morris County Planning Area (conforming)


#### Proposal

Proposed Map Adjustment: Portion of Protection Zone to Existing Community Zone

#### Rationale

To allow for a 100% affordable housing project

#### **Conditions include** (*among other requirements*)

- Completion of a Stormwater Management plan for the site
- Forest restoration
- Critical habitat analysis and mitigation measures
- Conservation easement on the remaining Protection Zone land
