CALL TO ORDER 219TH meeting of the New Jersey Highlands Water Protection and Planning Council was called to order at 4:00 pm at the Highlands Council Offices in Chester, NJ.

ROLL CALL

Roll call was taken. Members Alstede, Dougherty, James, and Smith were absent. All other Council Members were present. CHAIRMAN'S REPORT

Chair Richko announced there was no Chairman's Report and added that it was Administrative Assistant Diana Swiderski's debut and wished her good luck.

EXECUTIVE DIRECTOR'S REPORT

Mr. Spinelli reported on the following items:

1. Drought continues. Entire Highlands region is still in a moderate to severe drought, for a total of 27 months now. A long-term drought has serious impacts on agriculture and drinking water supplies, and ground water levels can take years to reverse. It is not a demand problem, but a supply problem that can best be addressed by properly funding the Highlands Council so we may do what is necessary to provide an adequate supply of drinking water to 70% of the state.
2. Recent meeting with American Farmland Trust (AFT) on June 16, 2026, which resulted in an exciting proposal regarding supporting sustainable agriculture within the Highlands region and the state. Partnering with AFT would offer us the benefit of having an agricultural specialist on staff, which is something Mr. Spinelli has been advocating for some time.
3. Open Space & Recreation Plan continues to move forward. We will have a version and presentation ready for the Council most likely at our July meeting.
4. Climate project data collection and analysis continue to move forward.
5. Mr. Spinelli and Planning Manager Maryjude Haddock-Weiler presented at the New Jersey American Planning Association Conference on June 12, 2026, which was very well received.
6. Met with representatives of Bernards Township, a 100% planning area town, on June 16, 2026, to discuss plan conformance.
7. Two pending bills are currently impacting the Highlands. One is a new Affordable Housing bill that would provide for the use of religious and non-profit properties to be used for affordable housing. It was amended to include a provision to respect the Highlands Regional Master Plan. The second bill is a proposal to provide enhanced school funding to municipalities in the Highlands region.
8. Difficult budget year for New Jersey. The Highlands Council is still operating on a 2011 budget. A modest additional investment is needed to add critical staff and access existing sources of funding for Open Space Preservation and Land Stewardship.
9. Committee meetings will be scheduled before our July Council meeting to discuss our Monitoring Program and Recommendations Report (MPRR), redevelopment procedures based on Council's concerns during our May meeting, as well as a new quarterly grant program.
10. Mr. Spinelli and Highlands Council science staff have been invited to join NJDEP Commissioner Ed Potosnak and his staff for a tour of Sparta Mountain.
11. Personnel – Offers were made to two candidates regarding open positions for Environmental Specialist 2 (Resource Management Specialist/Forester) and a part-time IT position. We are aiming for a start date during the week of July 27, 2026.

At this time, Chair Richko asked if any Council members had questions or comments on the Executive Director's report.

There were no questions/comments.
