**AN ORDINANCE REPEALING ORDINANCE 16-CODE-744 OF THE REVISED
GENERAL ORDINANCES OF THE BOROUGH OF OAKLAND**

WHEREAS, the Borough of Oakland has determined that it is in the best interest of the Borough to withdraw its petition for plan conformance for the Planning Area.


NOW THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Borough of Oakland, County of Bergen, State of New Jersey, as follows:

Section 1. Ordinance 16-CODE-744 of the Revised General Ordinances of the Borough of Oakland is hereby repealed in its entirety.

Section 2. Should any part, portion or provision of this ordinance be held unconstitutional or invalid, such decision shall not affect the validity of this ordinance as a whole, or any other part thereof

Section 3. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

Section 4. This ordinance shall take effect immediately upon publication and final passage according to law.
