### **Job Description:**

Protect and enhance water quality and quantity within the Highlands Region by assisting in the preparation of project reviews in the Highlands region and assisting in the review and preparation of resource management plans. Fieldwork required includes, but not limited to site evaluation, ecological assessment, easement monitoring, stewardship plan review and water quality monitoring. Provide technical support to staff when needed.

### **Duties:**

- Baseline property site inspections and on-going monitoring of preserved properties, proposed development projects, and mitigation properties.
- Coordination of site visits with landowners, government officials, and professionals as necessary.
- Review of site plans, aerial images and Highlands resources, and applicable Highlands Regional Master Plan (RMP) policies and objectives associated with Highlands Project Review.
- Assist in preparation and review of stream corridor restoration plans, lake management plans, habitat conservation and management plans, and other municipal or regional level resource management plans ensuring compliance with the RMP.
- Assist in municipal and county Plan Conformance Implementation tasks and the development and implementation of the RMP Monitoring Program Recommendations Report.
- Provide input and guidance on forestry and woodland related projects occurring in the region. Assist in the development and implementation of community forestry plans and provide guidance to municipalities, counties and private landowners regarding forestry best management practices.
- Assist in the identification of, writing and submission of grant applications (state, federal, other) to obtain funding for projects that further the goals, policies and objectives of the RMP.
- Participate in water quality monitoring program.
- Support development of the Highlands Region Outreach & Education Program including, development of materials on topics as directed by the Science Manager and conducting public presentations.
- Respond to public questions regarding the Highlands region and the rules and regulations associated with the Highlands Act.
- Provide support to other planning and science staff members on a project-specific basis as directed by the Science Manager.
