#### **Township of Pohatcong Petition for Plan Conformance Final Draft Consistency Review and Recommendations Report**

**Please take notice** that the Highlands Water Protection and Planning Council (Highlands Council) is now accepting public comments on the Township of Pohatcong's Petition for Plan Conformance and the Final Draft Consistency Review and Recommendations Report prepared by the Highlands Council staff, for consideration by the Highlands Council in its review of the Petition for Plan Conformance of Pohatcong Township, Warren County, New Jersey. Equal consideration will be given to comments regardless of how they are received.

Model documents comprising the various elements of a standard Petition for Plan Conformance were posted to the Highlands Council website between April 2009 and June 2010. The Township of Pohatcong's Petition for Plan Conformance was deemed administratively complete on March 16, 2010, and posted to the Highlands Council website on March 24, 2010. After receiving any public comments provided during the hearing, the agency may approve, reject, or approve with conditions the Petition for Plan Conformance.
