NOTICE: PUBLIC COMMENT PERIOD AND PUBLIC HEARING Oxford Township, Warren County, Petition for Plan Conformance Final Draft Consistency Review and Recommendations Report

Please take notice that the Highlands Water Protection and Planning Council (Highlands Council) is now accepting public comments on Oxford Township's Petition for Plan Conformance and the Final Draft Consistency Review and Recommendations Report, prepared by the Highlands Council staff, for consideration by the Highlands Council in its review of Oxford's Petition. Written public comments will be accepted through July 22, 2011, via email at maryjude.haddock-weiler@highlands.state.nj.us, via facsimile at the number listed above, or by mail to the address listed above. Equal consideration will be given to comments regardless of how they are received.

Model documents comprising the various elements of a standard Petition for Plan Conformance were posted to the Highlands Council website between April 2009 and June 2010. Oxford Township's Petition for Plan Conformance was deemed administratively complete on January 22, 2010, and posted to the Highlands Council website on February 1, 2010. The Final Draft Consistency Review and Recommendations Report for Oxford Township and all Petition materials are available for public review both in the offices of the Highlands Council (please call to arrange for in-office review), and at its website:

Please take further notice that, subsequent to the close of public comment, Oxford Township's Petition for Plan Conformance, in conjunction with the Final Consistency Review and Recommendations Report and all public comments received, will be the subject of a public hearing held by the Highlands Council pursuant to sections 14 and 15 of the Highlands Act. After receiving any public comments provided during the public hearing, the Highlands Council may approve, reject, or approve with conditions the Petition for Plan Conformance. The public hearing will be scheduled for an upcoming meeting of the Highlands Council and the date and time of the hearing will be announced with the release of a meeting agenda on the Highlands Council website at <http://www.highlands.state.nj.us/njhighlands/about/calend/>.

Please take further notice that, as Oxford Township has submitted a petition for Substantive Certification to the Council on Affordable Housing, public comments regarding that Plan's consistency with the Regional Master Plan may be submitted to the Highlands Council, while any specific comments on the formal approval of that Housing Element and Fair Share Plan (a Plan Conformance Petition requirement) may be submitted to the Council on Affordable Housing or its successor.
