PLEASE NOTE: New Jersey Law Enforcement Agencies (LEAs) that wish to participate MUST SUBMIT AN APPLICATION PACKAGE through the NJ State Coordinator's Office - the NJSP Support Services Unit.

- LEA must acquire governing body approval, via a formal resolution, to participate in the Program
- LEA's Chief Law Enforcement Officer (CLEO) must sign and submit the Program's State Plan of Operation
- CLEO must sign and submit the Controlled Equipment Certification (CEC) Form
- Application packages must be complete to be accepted: application, resolution, State Plan, CEC Form

Providing Equipment
to the Crimefighter

- The 1033 Program is administered by the Defense Logistics Agency (DLA) at the Federal level. DLA has the final say in any Program aspect – from application to acquisition.
- DLA is a branch of the Dept. of Defense (DoD).
- Our office at the State – embedded within the New Jersey State Police Office of Emergency Management Section – administers the Program for NJ on behalf of DLA. All inquiries & issues must be routed through the State rather than to DLA Headquarters directly. We are your sole points of contact.
- The Program is designed to take excess/surplus DoD property, no longer utilized by a DoD unit, and recycle it to make it utilizable once again.
- Transfers of property from DLA to Law Enforcement are conditional and there are explicit rules & regulations that must be followed by the receiving LEA. These regulations are explained in detail within the State Plan of Operation.
- All property transferred to local law enforcement agencies via this Program must be receipted for upon acquisition, and an annual inventory process is conducted to ensure custody of Program acquisitions.

NOT JUST MILITARY EQUIPMENT!

- Office furniture: desks, chairs, cubicles, conference tables, sofas, bookcases, file cabinets, lockers, whiteboards, etc.
- Heavy equipment: forklifts, cranes, construction, scientific, milling & agricultural equipment, etc.
- Vehicles: passenger motor vehicles, pickups, cargo trucks, wreckers, ATVs/UTVs, mules, scooters, bicycles, etc.
- First aid equipment: field gear as well as traditional medical supplies, personal protective equipment (PPE), stretchers, defibrillators, CPR manikins & other training aids, etc.
- Electronic devices: desktop & laptop computers, tablets, phones, speakers, keyboards, monitors, televisions & other display types, projectors, conferencing systems, printers, etc.
- Miscellaneous: trailers, generators, storage cases & containers, tools of every type, packs, pouches, tents, clothing, boots, aircraft, marine vessels, and much more

Property Available



Rescue, Safety and Environmental Protection Equipment such as tactical vehicles, watercraft and radios.

Field Gear

such as cots, blankets, heaters, floodlights and generators to support LEA operational readiness.



Tactics Equipment such as boots and many other individual tactical clothing and equipment.

Exercise Equipment such as treadmills, weights and bikes to maintain fitness standards.



Office Equipment such as copiers, fax machines and computers.

Training and Support Items such as microwaves, refrigerators and furniture for LEA operational readiness.

Who Can Participate?

Law Enforcement Agencies whose primary function is the enforcement of applicable Federal, State and local laws, and whose compensated Law Enforcement Officers have the powers of arrest and apprehension. OEMs and DOC elements are not eligible.
