



STATEWIDE CRIME SUMMARY - 2013

CRIME INDEX - VOLUME/RATE

- There were 192,914 Index offenses in 2013, a 7 percent decrease compared to 2012.
- The crime rate of the state is 21.8 victims for every 1,000 permanent inhabitants, a decrease of 7 percent compared to 2012.

ADDITIONAL ANALYSIS

- August with 18,688 offenses reported, recorded the highest incidence of Crime Index offenses while February was the lowest with 12,899 offenses.
- The total value of property stolen amounted to \$353.6 million in 2013, a decrease of 7 percent from 2012.
- Value of property recovered was \$105.8 million, resulting in a recovery rate of 30 percent.
- Stolen motor vehicles accounted for 39 percent of stolen property and 84 percent of the recovered property value.

CRIME INDEX ARRESTS/CLEARANCES

- A total of 43,385 persons were arrested for Index offenses, which represents a 3 percent decrease compared to 2012.
- Adult Index arrests decreased less than one-half of one percent and juvenile Index arrests decreased 15 percent.
- Crime Index arrests accounted for 13 percent of the total arrests in 2013.
- Males accounted for 69 percent of the Crime Index arrests and females accounted for 31 percent.
- Sixty percent of the Index arrests were white, 39 percent were black and 2 percent were other races.
- Hispanics accounted for 19 percent of the arrests for Index offenses.
- Police cleared 21 percent of the Index offenses and juveniles accounted for 9 percent of those clearances.

VIOLENT CRIME SUMMARY

This category consists of the following Index offenses: Murder, Rape, Robbery, Aggravated Assault.

VOLUME/RATE/TREND

- There were 25,452 violent crimes reported in 2013, a 1 percent decrease compared to the violent crimes reported in 2012.
- Violent crimes accounted for 13 percent of the total Crime Index.
- The violent crime rate decreased with 3 victims for every 1,000 permanent inhabitants compared to 2012.

ADDITIONAL ANALYSIS

- The highest number of violent crimes were reported in June with 2,353 offenses while the lowest number was reported in February with 1,650 offenses.
- The total value of property stolen as a result of violent crime was \$16.8 million in 2013 an increase of 39 percent from 2012.

ARRESTS/CLEARANCES

- There were 11,258 violent crime arrests, a decrease of 2 percent compared to 2012.
- Violent crime arrests accounted for 26 percent of the Index arrests and 3 percent of the total arrests during the year.
- Adult arrests for violent crime decreased 3 percent and juvenile arrests increased 1 percent.
- Adults accounted for 83 percent of the violent crime arrests while the remaining 17 percent were juveniles.
- Males accounted for 80 percent of the Crime Index arrests and females accounted for 20 percent.
- Forty-seven percent of those arrests were white, 52 percent were black and 2 percent were other races.
- Hispanics accounted for 22 percent of the arrests for violent crimes.
- Thirty-eight percent of violent crimes were cleared and juveniles accounted for 13 percent of those clearances.

NONVIOLENT CRIME SUMMARY

This category consists of the following Index offenses: Burglary, Larceny-Theft, Motor Vehicle Theft.

VOLUME/RATE/TREND

- There were 167,462 nonviolent crimes reported in 2013, a 8 percent decrease compared to nonviolent crimes reported in 2012.
- Nonviolent crimes accounted for 87 percent of the total Crime Index.
- The nonviolent crime rate decreased 8 percent to 18.9 victims for every 1,000 inhabitants in 2013.

ADDITIONAL ANALYSIS

- The highest number of nonviolent crimes were reported in August with 16,379 offenses while the lowest number was reported in February with 11,249 offenses.
- The total value of property stolen as a result of nonviolent crime was \$336.8 million in 2013 a decrease of 9 percent from 2012.

ARRESTS/CLEARANCES

- There were 32,127 nonviolent crime arrests, a decrease of 4 percent when compared to 2012.
- Nonviolent crime arrests accounted for 74 percent of the Index arrests and 10 percent of the total arrests during the year.
- Juveniles were responsible for 12 percent of the nonviolent crime arrests and adults 88 percent.
- Adult arrests for nonviolent crimes decreased 1 percent and juvenile arrests decreased 21 percent.

- Males represented 65 percent and females 35 percent of persons arrested for nonviolent crime.
- Sixty-four percent of all persons arrested for nonviolent crimes were white, 34 percent were black and 2 percent were other races.
- Hispanics accounted for 18 percent of the arrests for nonviolent crimes.
- Nineteen percent of all nonviolent crimes reported were cleared in 2013, and juveniles accounted for 8 percent of those clearances.

TOTAL ARREST SUMMARY

- There were 328,019 persons arrested in 2013, which represents a decrease of 4 percent compared to 2012.
- The arrest rate for 2013 decreased 4.4 percent with 37 persons arrested per every 1,000 inhabitants.
- Adult arrests decreased 3 percent to 303,225 and juvenile arrests decreased 17 percent to 24,795 in 2013.
- Adults accounted for 92 percent and juveniles 8 percent of the total state arrests.
- Persons under 21 years of age accounted for 19 percent of the total state arrests.
- Males accounted for 74 percent and females 26 percent of the total persons arrested during the year.
- Fifty-nine percent of total persons arrested in 2013 were white, 39 percent were black and 2 percent were other races.
- Hispanics accounted for 17 percent of the arrests.

POLICE OFFICERS KILLED AND ASSAULTED SUMMARY

- In 2013, no police officers were feloniously killed in the line of duty.
- In 2013, New Jersey reported 2,163 police officers assaulted in the line of duty.

CRIME IN NEW JERSEY, UNITED STATES AND THE NORTHEAST REGION

- Violent crime in New Jersey decreased 1 percent and the Northeast Region decreased 4 percent compared to the previous year, while violent crime in the United States decreased by 4 percent overall.
- Nonviolent crime in New Jersey decreased 8 percent, while the Northeast Region decreased 6 percent from the previous year. Nonviolent crime in the United States decreased 4 percent when compared to the 2012 figure.

MURDER

Definition:

Murder is defined as the unlawful killing of a human being with malice aforethought. Any death due to a fight, argument, quarrel, assault, or commission of a crime is included. This Index offense is counted by police on the basis of their investigation without regard to findings of a court, jury or the decision of a prosecutor. Attempts to kill, are scored as aggravated assaults and not as murder. Suicides, accidental deaths, negligent manslaughters, and justifiable homicides are not counted, nor reflected in the murder classification.

VOLUME/RATE/TREND

- There were 401 murders reported to law enforcement agencies of the state in 2013, a 4 percent increase compared to the 387 murders reported in 2012.
- Murders accounted for 0.21 percent of the reported index offenses, and 2 percent of the violent crime.

ADDITIONAL ANALYSIS

- The age group of 20-24 accounted for 22 percent of all murder victims.
- Firearms were used in 73 percent of the murders, knives or cutting instruments in 13 percent, physical force in 5 percent, and blunt objects in 3 percent.
- Twenty-one percent of the offenders were friends or acquaintances of the victim, while 14 percent were strangers, and 4
 percent were relatives.
- Felony murders accounted for 20 percent of all murder circumstances. Robbery was the motive in 56 percent of the 82 felony murders.
- Sixty-eight murders were recorded on Tuesday for the high, while Monday was the lowest, with 46.
- July recorded the highest number of murders 49, while March recorded the lowest 20.
- Fifty-four percent of the murders occured on highways or streets, 18 percent in single family dwellings, and 6 percent in multi-family apartment dwellings.
- Forty-four domestic violence murders were recorded in 2013.
- Drug-related and/or gang related circumstances accounted for 11 percent (43) of all murders.

ARRESTS/CLEARANCES

- A total of 238 persons were arrested for murder in 2013, a 7 percent increase compared to 2012.
- Adult murder arrests increased 9 percent (from 203 to 221) while juvenile arrests decreased 15 percent (from 20 to 17).
- Seventy-three percent of persons arrested for murder were black and 26 percent were white.
- Hispanics accounted for 11 percent of the arrests.

- Forty-nine percent of the murders were cleared in 2013 (196 out of 401). Juveniles accounted for 6 percent of those cases cleared.
- Males accounted for 92 percent and females 8 percent of those arrested for murder.







MURDER DISTRIBUTION BY TYPE OF WEAPON 2013





RELATIONSHIP OF MURDER VICTIMS TO OFFENDER





RAPE

Definition

Rape is defined as the carnal knowledge of a female forcibly and against her will. All assaults and attempts to rape are counted, but carnal abuse, rape without force (statutory rape) and other sex offenses are not included.

VOLUME/RATE/TREND

- There were 874 reported rapes in 2013, a 16 percent decrease compared to the 1,038 in 2012.
- Rape accounted for an increase of less than one-half of one percent of the total Crime Index and 3 percent of all violent crimes.

ADDITIONAL ANALYSIS

- Ninety-five percent of the rapes were forcible, the remaining 5 percent were attempts to rape.
- The total value of property stolen as a result of Rape amounted to \$13,660.

ARRESTS/CLEARANCES

- A total of 296 persons were arrested during 2013, a 7 percent decrease compared to 2012.
- Adult rape arrests decreased 7 percent, and juvenile arrests decreased 11 percent.
- Sixty-two percent of the arrested perpetrators were white, 36 percent were black and 1 percent were other races.
- Hispanics accounted for 38 percent of the arrests.

Most frequent month

- Thirty percent of all persons arrested for rape were between 25 and 39.
- Thirty-five percent of rape cases were cleared in 2013. Juveniles accounted for 10 percent of those cases cleared.

ROBBERY

Definition

Robbery is defined as the felonious and forcible taking of the property of another, against his will, by violence or by putting him in fear. The element of personal confrontation is always present in this crime. Under the program, all assaults or attempts to rob are included.

VOLUME/RATE/TREND

- There were 12,087 robbery offenses in 2013, an increase of 6 percent compared to 2012.
- Robbery accounted for 6 percent of the total Crime Index and 47 percent of all violent crimes.
- The robbery rate was 1.4 victims per 1,000 population.

ADDITIONAL ANALYSIS

- Highway robberies accounted for 66 percent of all reported robberies.
- Convenience store robberies increased 1 percent, while highway robberies increased 7 percent.
- The total value of property stolen during robberies amounted to \$16,689,972.


ARRESTS/CLEARANCES

- A total of 3,698 persons were arrested for robbery in 2013, a 4 percent increase compared to 2012.
- Adult robbery arrests increased 3 percent and juvenile robbery arrests changed 8 percent.
- Males accounted for 87 percent and females 13 percent of the robbery arrests during 2013.
- Sixty-four percent of all persons arrested for robbery were black, 35 percent were white, and 1 percent were other races.
- Hispanics accounted for 18 percent of the robbery arrests.
- Twenty-three percent of robbery cases were cleared and juveniles accounted for 20 percent of those clearances.

CARJACKING HIGHLIGHTS

Highlights of carjacking offense statistics for 2013 are listed below:

- There were 389 carjacking offenses reported to the police; which involved 429 victims, including passengers.
- Carjackings decreased 4% when comparing 2013 to 2012 reported offenses.
- Twenty-five of the 566 municipalities in New Jersey reported carjackings.
- Firearms were involved in 71% (277) of all carjackings. Less than one-half of one percent (1) of the firearms used were assault firearms. Shootings were involved in 2 percent (8) of all carjackings.
- New Jersey registered vehicles represented 86% (333) of all carjackings. Mercedes-Benz represented the most frequently carjacked vehicle at 12%. The most frequently targeted vehicle year was 2013 with 12% (47).
- Seventy-two percent (280) of all carjacked vehicles were recovered. The average value of a carjacked motor vehicle was \$12,355.
- Carjackings occurred in a residential area 85% (330) of the time. The hours of darkness (6:00 p.m. to 6:00 a.m.) accounted for 69% (269) of all carjackings.
- Eleven percent (41) of all carjackings were witnessed.
- The most frequent victim age group was 30-34, which accounted for 18% (76) of the victim total (429). Sixty-nine percent (298) of all victims were male. Fifty-three percent (227) of all victims were black.
- The total number of offenders was 772. Insufficient analysis information was supplied on 71% (549) of the offenders. Of all known offenders (223), 20-24 was the most frequent offender age group and accounted for 49% (109). Ninety-eight percent (219) of all known offenders were male. Eighty-nine percent (198) of all known offenders were black.
- Juveniles accounted for 11% (3) of the total arrests for carjacking (27), while adults accounted for 89% (24).
- January had the highest number of offenses with 49, accounting for 13% of all carjacking offenses.
- Sunday and Saturday recorded the highest number of offenses with (49) each, accounting for 13% of all carjackings.
- Region I, which consists of Essex, Hudson, and Union counties, accounted for 84% (328) of all carjackings.
- One murder was reported in 2013 as a result of carjacking.
- Five percent (19) of all carjackings (389) were cleared by arrest.

AGGRAVATED ASSAULT

Definition

Aggravated assault, as defined under the New Jersey Uniform Crime Reporting System, is an attempt or offer, with unlawful force or violence, to do serious physical injury to another. Attempts are included since it is not necessary that an injury result when a firearm, knife, or other weapon is used which could result in serious personal injury if the crime was successfully completed.

VOLUME/RATE/TREND

- There were 12,090 reported aggravated assaults in 2013, a decrease of 7 percent when compared to 2012.
- Aggravated assault accounted for 6 percent of the total Crime Index and 48 percent of all violent crimes.
- The rate for aggravated assault in 2013 decreased to 1.4 victims per 1000 population when compared to 2012.

ADDITIONAL ANALYSIS

- The categories of physical force (i.e. hands, fists, and feet) and other dangerous weapons (i.e. clubs, bricks, tire irons, etc.) were used in 60 percent of all reported aggravated assaults.
- Firearms were used in 19 percent of all aggravated assaults committed.


ARRESTS/CLEARANCES

- There were 7,026 persons arrested for aggravated assault in 2013, a 5 percent decrease compared to 2012.
- Adult arrests decreased 5 percent, and juvenile arrests decreased 5 percent.
- Males accounted for 75 percent and females 25 percent of the aggravated assault arrests.
- Fifty-three percent of all persons arrested for aggravated assaults were white, 45 percent were black, and the remaining 2 percent were other races.
- Hispanics accounted for 24 percent of the arrests.
- Fifty-two percent of aggravated assault cases were cleared; juveniles accounted for 10 percent of those clearances.

BURGLARY

DEFINITION

Under this program, burglary is defined as an unlawful entry or attempted entry of any structure to commit a felony or larceny. Data collection for this offense is further categorized as forcible entry, unlawful entry (where no force is used) and attempted forcible entry.

VOLUME/RATE/TREND

- There were 35,795 reported bulgary offenses in 2013, an 16 percent decrease when compared to 2012.
- Burglary accounted for 19 percent of the total Crime Index and 21 percent of all nonviolent crimes.
- The burglary rate was 4 victims per 1,000 population.

ADDITIONAL ANALYSIS

- Fifty-seven percent of all burglaries involved forcible entry, 32 percent were unlawful entry where no force was used and attempts to forcibly enter accounted for 10 percent in 2013.
- Residences were targets in 77 percent of the reported burglaries.
- Forty-three percent of nonresidential burglaries are known to have occurred between the hours of 6:00 p.m. and 6:00 a.m.
- Stolen property as a result of burglary statewide, amounted to \$75.7 million, for an average loss of \$2,114.
- The average loss as a result of residential burglaries was \$2,130 and of nonresidential burglaries was \$2,063.

ARRESTS/CLEARANCES

- Burglary arrests decreased 14 percent with 5,754 persons arrested.
- Adult arrests decreased 12 percent, and juvenile arrests decreased 19 percent.
- Males accounted for 86 percent, and females 14 percent of the burglary arrests.
- Juveniles accounted for 14 percent of all burglary arrests.
- Sixty-five percent of burglary arrests were white, 34 percent were black, and the remaining 1 percent were other races.
- Hispanics accounted for 19 percent of the arrests.
- Fourteen percent of the burglaries statewide were cleared and juveniles accounted for 7 percent of those clearances.

LARCENY-THEFT

Definition

The definition of larceny-theft, as provided under this program, is the taking of the property of another with intent to deprive him of ownership. All larcenies and thefts resulting from pocketpicking, purse-snatching, shoplifting, larcenies from motor vehicles, thefts or motor vehicle parts and accessories, bicycle thefts, etc., are included here. Embezzlement, unlawful conversions, larceny by bailee, frauds or bad checks are not included.

VOLUME/RATE/TREND

- There were 117,958 larcenies reported in 2013, a decrease of 4 percent compared to 2012.
- Larceny accounted for 61 percent of the total Crime Index and 70 percent of all nonviolent crimes.
- The rate for larceny was 13 victims per 1,000 population.

ADDITIONAL ANALYSIS

- Theft of motor vehicle parts and accessories and thefts from motor vehicles collectively accounted for 25 percent of all larceny-theft reported.
- Shoplifting offenses increased 3 percent when compared to 2012.
- Theft from buildings accounted for 18 percent of all larceny-thefts reported.

ARRESTS/CLEARANCES

- Larceny arrests decreased 1 percent in 2013 with 25,679 persons arrested.
- Adult arrests increased 2 percent, and juvenile arrests decreased 22 percent.
- Males accounted for 59 percent, and females 41 percent of the larceny arrests.
- Sixty-four percent of larceny arrests were white, 34 percent were black, and the remaining 2 percent were other races.
- Hispanics accounted for 17 percent of the arrests.
- Twenty-one percent of the larcenies were cleared with juveniles accounting for 8 percent of those clearances.

MOTOR VEHICLE THEFT

Definition

In Uniform Crime Reporting, motor vehicle theft includes all thefts and attempted thefts of a motor vehicle. This includes the theft or attempted theft of a motor vehicle which is defined as a self-propelled vehicle that runs on the surface and not on the rails. This definition excludes taking a motor vehicle for temporary use, such as family situation, or unauthorized use by others having lawful access to the vehicle. The motor vehicle theft category includes the subheadings of autos, trucks and buses, and other vehicles (motorcycles, mopeds, etc.)

VOLUME/RATE/TREND

- There were 13,709 motor vehicle thefts reported in 2013, a 17 percent decrease when compared to 2012.
- Motor vehicle theft accounted for 7 percent of the total Crime Index and 8 percent of all nonviolent crimes.
- The motor vehicle theft rate was 1.5 victims per 1000 population.

ADDITIONAL ANALYSIS

- Motor vehicles represented 39 percent of the total value of property stolen during 2013.
- Total value of stolen motor vehicles amounted to \$140 million during the year.
- The average value of a stolen motor vehicle was \$9,871.
- Recovered vehicle values totaling \$89 million represent 84 percent of the total value of recovered property.

ARRESTS/CLEARANCES

- A total of 694 persons arrested for Motor Vehicle Theft, this represents 0 percent change compared to 2012.
- Adult arrests increased less than one-half of one percent and juvenile arrests decreased 13 percent.
- Males accounted for 78 percent, and females 22 percent of the motor vehicle theft arrests.
- Fifty-eight percent of all persons arrested for motor vehicle theft were white and 41 percent were black.
- Hispanics accounted for 20 percent of the arrests.
- Six percent of motor vehicle thefts were cleared in 2013; juveniles accounted for 11 percent of those clearances.

MOTOR VEHICLE THEFT VALUES







ARSON

Definition

Arson is defined by the New Jersey Uniform Crime Reporting program as any willful or malicious burning or attempt to burn, with or without intent to defraud, a dwelling, house, public building, motor vehicle or aircraft, personal property of another, etc. Only fires determined through investigation to have been willfully or maliciously set are classified as arsons. Fires of suspicious or unknown origins are excluded.

VOLUME/RATE/TREND

- There were 664 reportable arsons in 2013, which represents a decrease of 20 percent when compared to 2012.
- The arson rate was 0.1 victims per 1,000 population.

ADDITIONAL ANALYSIS

- Forty-nine percent of arsons were structures, with single occupancy residences accounting for 23 percent.
- Mobile property, including motor vehicles, accounted for 23 percent of the arsons in the state.
- Other property (timber, crops, etc.) accounted for 28 percent of the reported arsons.
- Total value of property damage due to arson amounted to \$9.4 million, for an average loss of \$14,109.
- The average residential loss was \$33,127, while the average loss to industrial/commercial structures was \$9,874.
- The average loss to mobile property was \$6,902.

ARRESTS/CLEARANCES

- Arson arrests numbered 224 in 2013 representing 12 percent decrease, compared to 2012.
- Adult arrests increased 1 percent, and juvenile arrests decreased 25 percent.
- Males accounted for 79 percent, and females for 21 percent of the arson arrests.
- Juveniles accounted for 43 percent of all arsons arrests.
- Sixty-six percent of the persons arrested for arson were white, 31 percent were black, and the remaining 4 percent were other races.
- Hispanics accounted for 22 percent of the arrests.
- The arson clearance rate was 24 percent, and juveniles accounted for 36 percent of those clearances.
