Program Summary

This course will provide an overview of Title 30 law and related procedure. The presentation will include discussion regarding the decision to file guardianship litigation, service, evaluations and discovery, motions, pre-trial preparation, and trial presentation. An overview of the related Rules of Evidence will also be included.

Who Should Attend?

This program is intended for FG Deputy Attorneys General with the Division of Law's DYFS Practice Group only. Please do not attempt to register for this program if you have not been selected by your office to attend this program, selections for which have already been made.

Who Is the Faculty?

DAG Mary Jane Lembo Cullen is a graduate of Gonzaga University School of Law and was licensed to practice law in New Jersey in 1983. She was in private practice for six years before joining the Office of the Attorney General in 1990. She has litigated guardianship and protective service cases throughout her tenure as a Deputy. She is an Assistant Section Chief for DYFS Central. She has handled numerous cases wherein the applicability of ICWA was at issue, and she has organized and lectured at instructional workshops for DYFS staff on this topic.

DAG Lisa Landsman graduated from Cardozo School of Law in 1984 and has been a member of the New Jersey bar since 1984. She joined the Division of Law in January 1985 in the DYFS practice group and served as a lead deputy before being promoted to the Section Chief of DYFS-Central. Lisa has spent her entire legal career as a DYFS deputy, following a six year stint as a DYFS social worker in the adoption unit.
