#### **Program Summary**

This course is designed to give attorneys an understanding of best practices when they 1) propound discovery requests for electronic documents, and 2) when they receive a request for discovery of electronic documents. This course will also discuss preservation obligations, spoliation sanctions and the federal rules. It will also cover ethical considerations surrounding metadata.

#### Who Should Attend?

This program is open to all government attorneys, space allowing.

#### Who Is the Faculty?

Members of the NAGTRI's national faculty will be faculty for this program.

#### **How Do I Register?**

#### **State Employees**

Upon opening the AGAI Course Registration System home page, you will see the Create Account link in the Login Box. #### Non-State Employees or State Employees not Connected to the Garden State Network

If you are not a State employee, or are otherwise unable to access the AGAI Course Registration System through the Garden State Network, kindly email the Advocacy Institute at: AdvocacyInstitute@lps.state.nj.us for an authorization code to allow you access to the AGAI Course Registration System through the My New Jersey portal. Setting up your account through the portal is a two-step process, the details of which are set forth in the next two paragraphs.

Once you receive the portal authorization code you will be prompted to go to the My New Jersey portal at <a href="http://www.state.nj.us/">http://www.state.nj.us/</a> and create a portal account. Once your portal account is created you are prompted to enter your authorization code. This is Step 1 of the process, which you need only do once.

If you have already been issued an authorization code in the past you do not need to request another one. You can log into your account on the Garden State Network at http://www.state.nj.us and under the heading NJ L&PS Applications you will see the Attorney

General's Advocacy Institute's Registration System. Click on that and log into your account on our system.

Upon setting up your portal account, you need to set up your AGAI Course Registration System account. This is Step 2.
