### NEGOTIATION AND DISPUTE RESOLUTION WORKSHOP

#### **Program Summary**

This one-day workshop is specifically designed for attorneys and other legal professionals. Topics covered include negotiation theory and practice, the differences between mediation and arbitration, and how to use mediation to settle court cases. Role-play and discussion are stressed in this highly interactive workshop. Participants who complete this one-day workshop may then choose to attend an additional two-day training program that will qualify them to apply to be on the New Jersey State Court Mediation Roster.

#### Who Should Attend?

This program is recommended for all attorneys who handle civil or administrative matters involving negotiation, mediation, arbitration or other alternative dispute resolution process.

#### Who Is the Faculty?

**Eric R. Max** is the Director of the NJ Office of Dispute Settlement, which provides mediation services to resolve complex cases, and is a recognized leader in mediation and in teaching mediation skills.
