### **NEW JERSEY FIREARMS TRAINING**

#### *Program Summary*

This program has been developed to provide consistency and uniformity in the enforcement of New Jersey's gun permit laws. The curriculum will include pertinent theories, arguments and case law governing the applicable provisions of *N.J.S.A. 2C:58-3 et seq.* The scope of instruction will begin with a review of the fundamentals of evaluating and handling gun permit appeals, with an emphasis on "justifiable need." An overview of New Jersey state courts and Third Circuit opinions will also be examined in light of the growing litigation involving 2<sup>nd</sup> Amendment challenges. Finally, specific issues emanating from the Law Enforcement Officer Safety Act (LEOSA) of 2004 and 2010, as well as the Retired Law Enforcement Officer statute, will be addressed. The panel will allot time for a question and answer discussion at the end of the presentation.

This program is intended for Assistant Prosecutors and Deputy Attorneys General and Assistant Attorneys General. #### *Who Is the Faculty?*

**Assistant Prosecutor Cindy P. Glaser** is with the Middlesex County Prosecutor's Office and is currently the Section Chief of the Zone Prosecution Unit. She is also a Certified Instructor with the Police Training Commission and Legal Advisor to the Middlesex County Police Training Center. Assistant Prosecutor Glaser works as a Middlesex County Firearms Prosecutor. Prior to her current

position she was the Commander of the Middlesex County Narcotics Task Force. She is a member of the New Jersey and New York State Bar Associations. Ms. Glaser has been the Editor and Publisher of *MCPO in Brief* from 1998 to 2003, and the *Middlesex County Prosecutor's Office Search Warrant Manual*. She received her J.D. from Pace University School of Law in 1985 and B.A. from Cook College, Rutgers University in 1982.

**DAG Daniela Ivancikova** is with the Division of Law's Corrections and State Police Section wherein she is responsible for representing the Department of Corrections, Juvenile Justice Commission and Division of State Police in all phases of litigation in state, administrative and federal court. Prior to coming to the Division of Law in 2011, Daniela worked at White and Williams, LLP in Philadelphia as an associate in the Business Department. She Received her JD from Drexel University, College of Law in 2010, a Masters of Management, Strategic Management from Comenius University in Slovakia in 2004, and a Bachelor of Business Management in 2002 from Temple University in conjunction with Slovak Agricultural University in Slovakia. Among DAG Ivancikova's other accomplishments she received the Recognition Award for Exceptional Volunteer Service, Council of Spanish Speaking Organizations (2001-2005).

**AAG Tracy M.
