## **PROGRAM ANNOUNCEMENT**

### **HOW TO ETHICALLY PROSECUTE A CRIMINAL CASE AND AVOID REVERSIBLE ERROR**

#### ***Program Summary***

This program will focus on the ethical issues and concerns faced by a prosecutor in handling a criminal case. Topics include the duty to present exculpatory evidence to the grand jury, discovery and *Brady* obligations, appropriate areas for cross-examination, and how to avoid reversible error in opening statements and summations.

#### ***Who Should Attend?***

While this program is intended for attorneys handling criminal matters, others may find the subject matter of interest.

#### ***Who Is the Faculty?***

**AAG Carol Henderson** is Deputy Chief of the Appellate Bureau in the Division of Criminal Justice and has extensive experience litigating cases before the New Jersey Supreme Court, the Appellate Division, the United States District Court and the Third Circuit Court of Appeals. She has lectured and written articles on appellate practice, habeas litigation, sentencing, legal writing and prosecutor misconduct.

**Prosecutor Peter E. Warshaw, Jr.** is a 1983 graduate of the University of Delaware, and a 1986 graduate of the Delaware Law School of Widener University. Mr. Warshaw began his career with the Monmouth County Prosecutor's Office as a law clerk in September 1986, and was sworn in as an Assistant Prosecutor in September 1987. Prior to becoming Prosecutor, Mr. Warshaw served in a variety of staff and supervisory positions while with the Monmouth County Prosecutor's Office, culminating with his January 2006 appointment as First Assistant Prosecutor. In November 2010, Governor Christie nominated Mr. Warshaw to the Office of Monmouth County Prosecutor and, on

January 3, 2011, Attorney General Dow appointed him Acting Monmouth County Prosecutor. On January 31, 2011, Mr. Warshaw was sworn in as the Monmouth County Prosecutor. Mr. Warshaw is a certified criminal attorney, and served as either Chairman or Co-chairman of the Monmouth Bar Association's Criminal Practice Committee from 2002-2008. He has been a Trustee of the Monmouth Bar Association since 2007, and the Monmouth Bar Foundation since 2006. On October 29, 2010, Mr. Warshaw received the Career Advocacy Award for outstanding advocacy over a career from the New Jersey County Prosecutors Association.
