DIVISION OF CRIMINAL JUSTICE'S 2011 APPELLATE SYMPOSIUM

Program Summary

This day-long symposium will address hot topics and emerging issues in criminal law enforcement in New Jersey, including how to handle interlocutory appeals, emerging Second Amendment law, recent criminal law and procedure developments, and a "Q&A" session.

Who Should Attend?

This seminar is intended for deputy attorneys general, assistant prosecutors and detectives handling criminal matters. Other attorneys within the Department of Law and Public Safety, however, may find the topics being addressed of interest. This program is **not** open to any government attorneys beyond those identified above.

Who Is the Faculty?

AP Catherine Foddai is Chief of the Bergen County Prosecutor's Office's Appellate Section, which she joined in 2003 after 23 years with the Division's Appellate Bureau. She handles appeals, and assists with trial litigation. AP Foddai has been a member of the Model Jury Charge Committee since 1992, and has expertise in search and seizure law.

DAG Paul Heinzel is Chief of the Division's Appellate Bureau, where he has worked since 1993. He became the Bureau's Assistant Chief in 2002, Deputy Chief in 2007, and has been the Chief since 2008. He has argued before the Appellate Division, New Jersey Supreme Court, and Third Circuit on numerous occasions on multiple issues.

AAG Carol Henderson is Deputy Chief of the Division's Appellate Bureau, and litigates cases before all New Jersey federal and state courts. AAG Henderson has lectured and written articles on appellate practice, habeas litigation, sentencing, legal writing, prosecutor misconduct and PCR.

AP Nancy Hulett has been a member of the Appellate Section in the Middlesex County Prosecutor's Office since 2004. Before that, Nancy worked for 18 ½ years in the Division's Appellate Bureau doing criminal appeals in state and federal court.

AP Sara Liebman is the Supervisor of the Union County Prosecutor's Office's Appellate Unit, which she joined in 1995. She litigates in all New Jersey courts, trains new assistant prosecutors, and teaches search and seizure to police.

DAG Lori Linskey serves as a Senior Counsel within the NJ Division of Criminal Justice. In this capacity, DAG Linskey provides legal analysis on such issues as the Code of Ethics for County Prosecutors, eyewitness ID procedures, and firearms regulations.

DAG Frank Muroski has been with the Division's Appellate Bureau since 2001, and represents the State before the New Jersey Supreme Court and Appellate Division. Before that, Frank was an Assistant Prosecutor in the Union County Prosecutor's Office from 1995 to 2001, and was a judicial clerk for two Criminal Part judges.

AP Joie Piderit has been a Middlesex County Assistant Prosecutor in their Appellate Section since 2008, and before that was in both the Attorney General's Office and the New York County District Attorney's Office. She handles all phases of appellate litigation.

DAG Gregory Spellmeyer is in the Office of the Attorney General, Legal Affairs and Employee Relations. He joined the Division of Law in 1997, and became Assistant Section Chief for the State Police Section in 2002 before moving to the Division's Director's Office in 2007.

DAG Michael Williams is Deputy Chief of the Division's Appellate Bureau, where he has worked since 1988. He represents the State in all New Jersey federal and state courts, and has taught seminars on appellate practice, prosecutor summations, the use of hearsay following *Crawford v. Washington*, and immigration consequences of criminal convictions.
