Program Summary

This two-day seminar series is the second phase of an integrated three-phase course designed for new assistant prosecutors and deputy attorneys general, which culminates with an intensive four-day trial advocacy program. *Please see the attached schedule for the topics to be discussed during this two-day session.*

Who Should Attend?

This program is intended for new assistant prosecutors and Division of Criminal Justice deputies, attendance for which is determined by each office.

Who Is the Faculty?

The faculty consists of experienced assistant prosecutors and Division of Criminal Justice deputy attorneys general who have extensive expertise in the subject matter on which they are presenting.
