This informative and thought provoking presentation will focus upon the artistry of developing and delivering a persuasive closing argument. Particular attention will be paid to developing a closing argument that effectively weaves the factual, legal and persuasive theories of your case while minimizing the strengths of the other side's case. Those who attend will leave with a better understanding of the mechanics of developing a persuasive closing argument, and strategies for delivering a compelling one.

### Who Should Attend?

# Non-State Employees or State Employees not Connected to the Garden State Network
