## STATE HOUSE ROUND TABLE: OPEN PUBLIC RECORDS ACT ("OPRA")

### **Program Summary**

This presentation will provide a basic overview of the requirements under the Open Public Records Act (OPRA). This program will include an examination of the OPRA law itself, and the requirements imposed thereunder upon all government employees, including attorneys and non-attorneys. The program will also provide perspective and insights into the practical problems and legal issues which confront records custodians and their legal counsel on a daily basis. This presentation will give those attending the opportunity to participate in an informal question and answer period to discuss the intricacies of the requirements under OPRA.
