## OVERVIEW OF NEW JERSEY BAIL RULES AND PRACTICES

## **Program Summary**

This presentation will provide a general overview of current bail laws and practices, focusing on systemic deficiencies that undermine public safety. The presentation will explore ways that prosecutors can help to promote bail reform. Course topics will include: the "right to bail" under the New Jersey Constitution; preventive detention: myths and misconceptions about *State v. Johnson*; addressing witness/victim intimidation; the 10% option and "cash only" bail; addressing over-reliance on monetary bail: making greater use of non-monetary, conduct-based release conditions; the lack of a pre-trial services agency; bail source and sufficiency hearings; forfeiture of bail and "remission" practices; and opportunities for meaningful legislative reform (proposals and open discussion).

This program is intended for County Prosecutors and others invited to attend this program. Please do not attempt to register for this program if you are not a County Prosecutor, or a person otherwise invited to attend.

**AAG Ron Susswein** has served for a combined 29 years as a DAG/AAG in the Division of Criminal Justice and the Union County Prosecutor's Office. During his career, AAG Susswein helped to draft many of the Attorney General directives and guidelines that are designed to channel a prosecutor's plea bargaining discretion, including the policies concerning "Brimage," "Graves Act," "NERA," and public corruption cases.
