### **Program Summary**

Practitioners everywhere are faced with the daunting task of investigating allegations of fraud. Implementing and administering sound investigative approaches is critical to the success of any fraud investigation. Attorneys use internal and external resources to address these issues but where should they concentrate their efforts? In this two hour instructor led course, you will develop an understanding of the following concepts: elements of fraud, characteristics of the fraudster, forensic investigation strategies and techniques, common fraud schemes and the importance of data analytics, the forensic interview and documenting the results of your investigation.

#### Who Should Attend?

While this program is intended for those attorneys handling fraud matters, others may find the issues discussed of interest.

#### Who Is the Faculty?

William J. Amadio is currently Director at the Center for Business Forensics at Rider University College of Business Administration in Lawrenceville, New Jersey, wherein he secured start-up and on-going funding for an entrepreneurial venture to integrate teaching and research across the fields of information technology, accounting and law. Research sponsored by the center has led to a Fraud and Forensics concentration in Rider's Masters of Accountancy degree, an online training archive on social media technologies for law enforcement and a continuing professional education series that includes programs in identity theft, occupation fraud, money laundering and social media. He is also currently a Professor of Information Systems at Rider University, College of Business Administration from 1974 to present. He

received a B.S. in Mathematics in 1970 from Brooklyn College and an M.S. in Mathematics in 1973 from Polytechnic Institute of New York University and his Ph.D. in 1975 in Mathematics, his specialty being *probability and statistics*, also from Polytechnic Institute of New York University. Some of his accomplishments, to name a few; he led the founding of Rider's Center for Business Forensics, an entrepreneurial venture responding to the growing threats of fraud and cyber-crime; he received the Christian R. and Mary F. Lindback Foundation Award for Distinguished Teaching and was most influential faculty member in 2005, 2006, 2011 and 2012. He has several publications and presentations under his belt, including most recently: "Modern Text Analytics", NJCPA Business Valuation, Forensic Investigation & Litigation Services Conference, "Examination of Relevance Criteria Choices and the Information SearchProcess" with A. Taylor, et al, *Journal of Documentation*; "Self-Expression in Technical Courses: Making it Happen", *American Journal of Business Education*, to name a few.

He also recently wrote a graduate-level forensic accounting course for Thomas Edison State College.
