PROSECUTOR ALCOTEST TRAINING

Program Summary

This program will provide an overview of the basics of a DWI prosecution and will include instruction, by a certified breath test coordinator, on how the Alcotest 7110 MK-IIIC works, a demonstration of a re-calibration of an Alcotest instrument, and a demonstration of how a breath test is conducted. This program will also review current hot topics being raised by defense attorneys in DWI prosecutions, including repair records, discovery issues, RFI/EMI Interference, the central database, data deletion, twenty-minute observation period, Standard Statement & the Ignition Interlock device, and the 2-minute lockout.

Who Should Attend?

This program is open to municipal and county assistant prosecutors as well as deputy and assistant attorneys general within the Division of Criminal Justice only.

Who Is the Faculty?

Robyn Mitchell is a Deputy Attorney General with the New Jersey Division of Criminal Justice. DAG Mitchell joined the Division in January 2000, where she worked in the Legislation Section until 2003, and in the Appellate Bureau between 2003 and 2011. Assigned to the Prosecutors Supervision & Coordination Bureau since March 2011, DAG Mitchell handles matters involving DWI and Alcotest-related issues, and provides legal guidance and support to assistant and municipal prosecutors in the prosecution of DWI cases. She started her career in 1991 as a Staff Attorney in the Criminal Defense Division of The Legal Aid Society in Manhattan. She received her B.A. degree in 1988 from Rutgers College and her J.D. in 1991 from The University of Maryland School of Law in Baltimore, Maryland.

Acting Sergeant Thomas J. Snyder is currently assigned to the Alcohol Drug Testing Unit's south training team, wherein his responsibilities include the scheduling and instruction of the following courses: Four Day Alcotest 7110 MKIII-C Operator's Course, Alcotest 7110 MKIII-C Recertification Course, DWI Detection and Standardized Field Sobriety Testing Course, DWI Detection and Standardized Field Sobriety Testing Refresher Course, Drug Recognition Expert Course and Advanced Roadside Impaired Driving Enforcement Course. Prior to his current assignment, he was assigned as a Breath Test Coordinator/Instructor for New Jersey's northern and southern counties, he was also assigned to Alcohol/Drug Test Unit Coordinator Training where he apprenticed with certified Coordinators/Instructors and received formal training and one-on-one instruction relative to the inspection and maintenance of evidential instruments. He is certified by Draeger Safety Diagnostics to train and certify operators in the proper use and operation, as well as perform preventive maintenance on the New Jersey Specific Alcotest 7110 MKIII-C. He received a Masters of Arts degree in Police Graduate Studies from Seton Hall University in 2008, graduated with Honors, Cum Laude from Richard Stockton College of New Jersey in 1995 with a Bachelor of Arts Degree in Criminal Justice and from Ocean County College in 1993 with an Associate of Science Degree in Criminal Justice also with Honors, Cum Laude. He has also attended many technical and professional trainings.

Detective I. Harold Weyman #6289 is currently with the Alcohol/Drug Testing Unit. Some of his prior assignments include; the Casino Investigation Unit, the Atlantic City Expressway Station, Field Operation Section and the New Jersey Department of Corrections, prior to that he was in the United States Navy. He received his Associates of Science from Cumberland County College in May, 2005 and has 96 credits at Fairleigh Dickinson University. He also has Specialized Training in areas such as; the Alcotest 7110 MK III-C Operator Refresher course, Draeger Safety Diagnostic, Inc.'s Alcotest 7110 MK III-C memory data download training, New Jersey Attorney General Breath Test Coordinator/Instructor Training, and Instructor Training in DWI Detection and Standardized Field Sobriety Testing, among others.

Once you receive the portal authorization code you will be prompted to go to the My New Jersey portal at http://www.state.nj.us/ and create a portal account. This is Step 1 of the process, which you need only do once.
