# NEGOTIATION AND DISPUTE RESOLUTION WORKSHOP

### **Program Summary**

This one-day workshop is specifically designed for attorneys and other legal professionals. Topics covered include negotiation theory and practice, the differences between mediation and arbitration, and how to use mediation to settle court cases. Role-play and discussion are stressed in this highly interactive workshop. Participants who complete this one-day workshop may then choose to attend an additional two-day training program that will qualify them to apply to be on the New Jersey State Court Mediation Roster.

#### Who Should Attend?

This program is recommended for all attorneys who handle civil or administrative matters involving negotiation, mediation, arbitration or other alternative dispute resolution process.

#### Who Is the Faculty?

Eric R. Max is Director of the New Jersey State Office of Dispute Settlement (ODS) and an adjunct professor at New York University School of Law where he teaches mediation. ODS is one of the leading mediation offices in the country, mediating over 50 cases each year for the state and federal courts. Mr. Max has personally served as a court-appointed mediator in over 1,000 cases and settled claims in excess of \$1 billion. Mr. Max is a recipient of the CPR Legal Program's National Award for "Outstanding Practical Achievement in Dispute Resolution" for his mediation of complex public disputes.

A couple of significant cases that Mr. Max has mediated are: \$100 million federal class action lawsuit involving the proposed demolition of all high-rise public housing in Newark and \$100 million litigation between the state of New Jersey and two Fortune 500 companies regarding the construction of a light rail line.

In addition, Mr. Max has trained hundreds of judges, attorneys and senior state officials in mediation and settlement techniques. Specific groups trained include: Superior Court Judges, Administrative Law Judges, Office of the Attorney General, State Police and attorneys serving on the State Court Mediation Roster. Published articles include: *Confidentiality in Environmental Mediation*, 2 N.Y.U. Environmental Law Journal 219 (1993) and *Bench Manual for the Appointment of a Mediator*, 136 Federal Rules Decisions 499 (1991). Mr. Max has been a member of three federal court mediation panels, the N.J. Supreme Court Committee on Complimentary Dispute Resolution and has spoken at both the Third Circuit Judicial Conference and the N.J. Judicial College. Mr. Max received a Specialization in Negotiation and Dispute Resolution from the Harvard Law School Program on Negotiation and a J.D. from Boston University School of Law.

### Non-State Employees or State Employees not Connected to the Garden State Network
