# USE OF EXPERT TESTIMONY IN DRUG PROSECUTIONS

## **Program Summary**

This program will provide an overview addressing the State's use of expert testimony in drug prosecutions from <u>State v. Odom</u> to the Supreme Court's most recent pronouncement in <u>State v.</u> <u>Sowell</u>. Consistent with a recent Attorney General letter to all prosecutors stressing the importance of limiting the use of such testimony to areas beyond the understanding of the jury, the program will focus on the appropriate and inappropriate use of expert opinion under <u>N.J.R.E.</u> 702 and how to properly frame hypothetical questions in drug cases.

#### Who Should Attend?

This program is open to county assistant prosecutors as well as deputy and assistant attorneys general within the Division of Criminal Justice **only**. Please do not attempt to register for this program if you are not a county assistant prosecutor or deputy or assistant attorney general with the Division of Criminal Justice.

#### Who Is the Faculty?

**DAG Philip J. Mogavero** has been assigned to the Gangs and Organized Crime Bureau since 2007. From 2001, when he joined the office, until 2007 DAG Mogavero was assigned to the Office of the Insurance Fraud Prosecutor within the Attorney General's Office. Since 2011 DAG Mogavero has been a member of the New Jersey Attorney General's Shooting Response Team and is responsible for investigating police shootings and in custody death cases. Prior to joining the Attorney General's Office DAG Mogavero became a Certified Trial Attorney in 1996. From 1993 to 2001 DAG Mogavero was an Insurance Defense Attorney for several insurance companies. From 1989 to 1993 he was an Assistant Prosecutor with the Essex County

Prosecutor's Office. DAG Mogavero obtained his undergraduate degree from Northeastern University in 1984, and his law degree from The Ohio Northern University, School of Law in 1987.

**Steven Yomtov** is a Deputy Attorney General and Senior Counsel with the New Jersey Division of Criminal Justice. DAG Yomtov is assigned to the Appellate Bureau where he has worked since he joined the Division in April 1999. DAG Yomtov litigates appellate matters in both state and federal courts, and routinely appears in the Appellate Division and the New Jersey Supreme Court. He also provides counsel to law enforcement agencies throughout the State primarily in the area of search and seizure. DAG Yomtov began his career in 1994 as an Assistant District Attorney in the Appeals Bureau of the Bronx District Attorney's Office. He received both his Bachelor's and Master's Degrees in Political Science from Binghamton University in 1988 and 1989, respectively, and his J.D. from Pace University School of Law in 1994. Following graduate school, he served as a Governor's Fellow at the New Jersey Office of Management and Budget.

## Non-State Employees or State Employees not Connected to the Garden State Network
