Program Summary

Jury Selection is a critical part of the trial process. Selecting the proper jury to decide your case is vital to protecting your client's interests. During this thought provoking presentation, Judge Shipp will share insights into the jury selection process. Those in attendance will gain a better understanding of the mechanics of jury selection as well as the considerations that should be kept in mind when selecting a jury. All attorneys regardless of their experience level will benefit from this presentation.

Who Is the Faculty?

Michael A. Shipp, U.S.D.J., was nominated to the District Court, District of New Jersey by President Obama on January 23, 2012 and confirmed by the Senate on July 23, 2012. He received his commission on July 26, 2012 to the U.S. District Court, District of New Jersey. Prior to being nominated by President Obama to his current appointment, Judge Shipp was a U.S. Magistrate Judge for the U.S. District Court, District of New Jersey from 2007-2012. Judge Shipp graduated from Rutgers University in 1987 and Seton Hall University, School of Law in 1994. He clerked for the Honorable James H. Coleman, Jr., New Jersey Supreme Court from 1994 to 1995 and went into private practice directly following his clerkship. In 2003 he began working for the State of New Jersey as an Assistant Attorney General and was Counsel to the Attorney General in 2007.

Non-State Employees or State Employees not Connected to the Garden State Network

Click on it and create your account, which will include you selecting a new user name and password.
