LITIGATING AN OPRA CASE

Program Summary

Public agencies face numerous Open Public Records Act (OPRA) lawsuits and Government Records Council (GRC) complaints concerning their handling of OPRA requests. This presentation will discuss the special procedures and issues applicable to litigating OPRA cases in the trial court and before the GRC on behalf of public agencies. In addition to covering procedural issues, this program will provide tips on topics such as key legal defenses, in camera review, privilege logs, attorney fee awards and common law right to know claims. This presentation will be geared toward attorneys of all experience levels.

Who Should Attend?

This program is intended for those attorneys who litigate OPRA matters. Others, however, may find the issues discussed of interest.

Who Is the Faculty?

AAG Lewis Scheindlin is an Assistant Attorney General for Appeals, Division of Law. Since Enactment of OPRA in 2002, AAG Scheindlin has supervised all OPRA litigation and legal advice for the State, and has directly handled a number of significant OPRA cases in the Appellate Division and New Jersey Supreme Court. AAG Scheindlin is a frequent presenter for the Attorney General's Advocacy Institute on topics including OPRA, appellate practice and attorney-client privilege and the work product doctrine.
