TRIAL ADVOCACY TRAINING

Program Summary

This intensive 4-day trial advocacy program combines presentations and learn-by-doing workshops, culminating in a mock trial on the last day. The presentations, which will be by experienced faculty, will cover direct emanation, cross examination, persuasive use of exhibits, case theory, opening statements, closing arguments, and the ethics of witness preparation. The participants, in turn, will perform in a series of learn-by-doing workshops, in which they will incorporate what they learned from the presentations and others in dealing with discrete phases of the trial process. All participants then will "try" their case in a mock trial on the last day of the program.

Who Should Attend?

This program is intended for attorneys with little or no trial experience. While not a prerequisite, if you intend to take the Attorney General Advocacy Institute's Deposition Skills program, it is strongly recommended that Deposition Skills be completed prior to enrolling in this program. Those who register for this program must secure the approval of their supervisor prior to enrollment in this program.

Who Is the Faculty?

Experienced members of the Advocacy Institute's faculty will be faculty for this program.

CLE Credit

NJ CLE Credit: This program has been approved by the Board on Continuing Legal Education of the Supreme Court of New Jersey for 26.4 hours of total CLE credit. Of these, 1.2 qualify as hours of credit for ethics/professionalism, and 26.4 qualify as hours of credit toward certification

in civil trial, criminal trial law, and workers compensation law. Also, substantive credits earned for this program should apply toward "newly admitted" attorneys' *Bridge the Gap* requirements.

NY CLE Credit: 25.0 substantive and 1.0 ethics credits (pursuant to the approved jurisdiction policy).

PA CLE Credit: 21.0 substantive and 1.0 ethics credits (\$1.50 per credit mandatory registration fee required).
