Program Summary

This two-day seminar series is the first phase of an integrated three-phase course designed for new assistant prosecutors and deputy attorneys general, which culminates with an intensive four-day trial advocacy program. Among the topics addressed during this session will be Bias Crimes, Gang Issues, Ethics Issues, Grand Jury Issues, Confessions/Miranda Issues, Trial Ethics Issues, Bail Issues, Persuasive Motion Practice Issues and Juvenile Justice Issues.

Who Should Attend?

This program is intended for new assistant prosecutors and Division of Criminal Justice deputies, attendance for which is determined by each county prosecutor's office and the Division of Criminal Justice. Please do not attempt to register for this program if you have not already been notified of your eligibility to attend.

Who Is the Faculty?

The faculty consists of experienced assistant prosecutors, Division of Criminal Justice attorneys, and private sector attorneys who have extensive expertise in the subject matter on which they are presenting.

CLE Credit

NJ CLE Credit: This program has been approved by the Board on Continuing Legal Education of the Supreme Court of New Jersey for 12.8 hours of total CLE credit. Of these 2.4, qualify as hours of credit for ethics/professionalism. Moreover, certain of these presentations may qualify to satisfy the attendees' *Bridge the Gap* obligations.

Non-State Employees or State Employees not Connected to the Garden State Network
