COURSE DESCRIPTIONS AND FACULTY INFORMATION

STATE REGULATORY CHANGES & CHALLENGES – OCEAN A, B

Regulators throughout this region and around the country have been struggling with whether and how alcoholic beverage regulation should evolve with the times. How important is it to maintain a strict three-tier system for all products and licensees? What limits should we put on social media advertising and promotional events? How do we ensure fair access to alcoholic beverages while maintaining the public health? This panel will examine how regulators address the concerns of those involved in the alcoholic beverage industry – both the licensees and consumers – while also protecting the public at large. Regulators and industry members will discuss how to deal with these forces that often pull in opposite directions and which must be addressed within the strict construct imposed by legislatures. INTERNET DIRECT SHIP - THE NEXT GENERATION

In a post-*Granholm* world, what are the limits of direct shipping of alcoholic beverages? Are state's permitted to regulate or ban retailer to consumer, Brewer and/or distiller to consumer, or distiller to retailer direct shipping? Is the three-tier system unquestionably legitimate as indicated in *Granholm* or will the Commerce Clause continue to trump the 21st Amendment? (October 10, 2013 11:00 a.m. to 12:00 p.m.)

Moderator: **Robert J. O'hara, II** received his J.D., cum laude, from the University of Dayton in 1989 and his B.A. in English in 1985 from the same school. He served as Articles Editor of the University of Dayton Law Review and is a member of the National Honors Society in History.

OPERATION SWILL- NEW JERSEY INVESTIGATION

This investigation by the New Jersey Division of Alcoholic Beverage Control garnered international headlines when it revealed the extent to which premium alcoholic beverages were substituted for less expensive brands. Details of the investigation, from origins to conclusion, will be presented, and the NJ ABC's roadmap forward will be outlined. (The Investigation continues, limiting some of the details that may be presented). (October 10, 2013 2:30 p.m. to 4:00 p.m.)

Moderator: **Director Michael I. Halfacre** was appointed as Director of the Division of Alcoholic Beverage Control by Governor Chris Christie. He began his work as Acting Director on February 6, 2012 and, after New Jersey Senate confirmation, was sworn in as Director on March 30, 2012. Prior to his appointment as Director, Mr. Halfacre was in private practice, including having his own firm where he specialized in transactions, including sales and refinance of real estate and transfers of ABC licenses. During this time Director Halfacre also served as a municipal prosecutor in Little Silver and Rumson, where he argued for convictions for drunk drivers and adults who provided alcohol to underage drinkers. While in the private sector, Director Halfacre served as a trustee of the New Jersey State Bar Foundation, Ocean-Monmouth Legal Services and the Monmouth Bar Association. A lifelong resident of Fair Haven, Director Halfacre served in various elected and appointed positions in the municipality, including serving as Mayor from 2007 through his appointment as Director of the Division of Alcoholic Beverage Control. Director Halfacre earned his undergraduate degree in Political Science from Florida State University, where he was the co-captain of the varsity swimming team. He later earned his law degree from the University of Dayton. He was admitted to the New Jersey Bar in 1991.

Panelists: John A. Cocklin is the Bureau Chief for the New Jersey Division of Alcoholic Beverage Control's Investigations Bureau. He has been associated with the ABC as an investigator since his retirement from the Division of Criminal Justice. John supervises the Division's investigative personnel who conduct investigations and administrative inspections of the State's approximately ten thousand licensed alcoholic beverage establishments. John retired from the New Jersey Division of Criminal Justice where he served for twenty-three years and rose to the rank of the Chief State Investigator. Chief Cocklin (Retired) was instrumental in the development and implementation of asset forfeiture training for every law enforcement officer in New Jersey, as well as a principal author of the State of New Jersey Forfeiture Program Administration Standard Operating Procedures. At the request of the Israeli National Police, John assisted in the development and implementation of a comprehensive asset forfeiture program against narcotics traffickers operating within Israel. He is a certified New Jersey Police Training Commission instructor. John is a member of the New Jersey Association of Chiefs of Police (Retired) and the International Association of Chiefs of Police, where he served from 1999 to 2002 as a member of the association's Advisory Committee for Police Investigative Operations. A graduate of York College of Pennsylvania with dual majors in Accounting and Criminal Justice, John obtained a Masters in Business Administration from Rider University, (College). Chief Cocklin (Retired) is a New Jersey Certified Public Manager, graduating from the Certified Public Manager program affiliated with Rutgers, the State University.

Kevin Marc Schatz is a Senior Deputy Attorney General who has been with the New Jersey Attorney General's Office since 1991 and has represented numerous state agencies. Since 1999, he has served as ABC's Assistant Bureau Chief of the Enforcement Bureau and Supervisor of litigation. He handles the most complex cases. He also assists the Bureau Chief in establishing policy and procedures for the Bureau. He has earned L.L.M. (Taxation), J.D. and M.B.A. degrees from Widener University and a B.S. from St. Joseph's University.

COOPERATION: REGULATORS AND INDUSTRY WORKING FOR A COMMON GOAL

Questions to be answered are: What do regulators want from industry and vice versa? How have the initiatives taken hold and where have they been more/less successful? Moderator: **Nicholas J. Bergman** is the Resident Partner in the firm's New York office. Nicholas was born in Cleveland, Ohio in 1970. Ms. McNerney received a B.A. degree from SUNY Purchase, a MBA and JD degrees from Fordham.

John Yeomans was appointed as Director of the Division of Alcohol & Tobacco Enforcement (ATE) by Governor Jack Markell in January, 2011. Prior to his appointment, Director Yeomans retired as a Captain from the Delaware State Police in 2007, after 25 years of service. During his tenure with the Delaware State Police, Director Yeomans served in a number of different units including, Troop Commander, Director of Human Resources, Director of Public Information Office, Internal Affairs, Homicide, Executive Staff Support, Criminal Investigations and Patrol. Director Yeomans also founded and was team coordinator for the State Police Critical Incident Stress Management Team, which provides support for both sworn and civilian personnel who are involved in a traumatic job related episodes. Appriss is a technology company that supports Criminal Justice organizations with a series of software solutions.

Hear about the history of winemaking in the Garden State, from the days of New Jersey's first winery, Welches and Prohibition, to today's thriving wine industry. Discussion will cover statutes and Regulations and their impact on the industry, the evolution of the Garden State Wine Growers Association and the growth of the industry from the 1970's through the Freeman litigation to the present. The legislative response to Freeman, and other current legislation will also be discussed. Finally, the success of New Jersey wines at blind tastings such as the "Judgment at Princeton" and the future of wine in New Jersey will be covered, including wine tourism efforts. TAX AND TRADE BUREAU COLA CHANGES: THE DISCUSSION CONTINUES – OCEAN A, B

The Tax and Trade Bureau has begun a substantial overhaul of its label pre-approval process. Suppliers, wholesalers, state agencies, and others depend on the Certificate of Label Approval (COLA) for different purposes. If the COLA as we know it goes away, industry members and states that have state-level label approval regulations may need to review and revise their processes, too. Come prepared to learn, engage, and discuss the future of label approvals at both the federal and state levels. (October 12, 2013 9:00 a.m. to 10:15 a.m.)

Moderator: **Jeff Carroll**, is Vice President for Compliance & Strategy at ShipCompliant. He heads the Strategy and Compliance arms of ShipCompliant. In this role since 2005, Jeff is charged with overseeing the direction and update of ShipCompliant products and services that allow producers and importers of alcohol beverages to accurately comply with 1000's of state and federal alcohol laws and regulations and ship and distribute their products efficiently. In addition, Jeff overseas a team that constantly monitors changes in alcohol regulations across the country and works with regulators at the state and federal level to assure ShipCompliant tools and services meet the evolving needs of their clients. Jeff is often invited to speak at industry events where regulatory and political topics are discussed and debated. In addition, he is a regular contributor to various wine industry trade publications.

In July 2005 Susan was appointed to the newly-created position of TTB Executive Liaison for Industry and State Matters. In that position Susan concentrates on enhancing communication, education and customer service.
