## AN OVERVIEW OF THE NEW JERSEY AND FEDERAL FALSE CLAIMS ACTS

## **Program Summary**

This presentation will provide an overview of the New Jersey False Claims Act, and will include a discussion of the parallel Federal False Claims Act and the recent recoveries obtained by states and the federal government under these powerful tools to combat fraud against the government. The presentation will cover the key provisions of the New Jersey statute, and relevant developing state and federal case law. It will also address the anatomy of a false claims act investigation, whether filed in federal or state court, and practical considerations in investigating false claims act matters and deciding whether the State should intervene, and will review recent settlements of the Government and HealthCare Fraud Section.

**Janine Matton** is a Deputy Attorney General and the Assistant Chief in the Government & Healthcare Fraud Section, where she is responsible for the investigation and litigation of complex False Claims Act matters and other affirmative cases focusing on consumer, healthcare,

securities and government fraud. Janine joined the Department of Law and Public Safety in 2007 serving as a Special Assistant to Attorneys General Rabner and Milgram. She was a law clerk to the Honorable Virginia A. Long during the 2003-2004 term. Janine is a 2003 graduate of Columbia University School of Law, where she was a Harlan Fiske Stone Scholar. Janine also holds an M.A. in Economics, from Rutgers University, and has over eleven years of experience in market analysis in the telecommunications and pharmaceutical industries.

**Michelle Weiner** has served as a Deputy Attorney General since 2003 and began her career as a Deputy Attorney General, in the Consumer Affairs Counseling section, where she counselled the Board of Medical Examiners on federal and state health care anti-kickback and anti-referral laws and the corporate practice of medicine. She is currently in the Government & Healthcare Fraud section, where she concentrates on healthcare fraud. She provided advice when the New Jersey False Claims Act was drafted. Michelle came to the Division of Law from the U.S. Attorney's Office, Eastern District of New York, where she received awards for sustained superior performance during her ten years of service. She is a graduate of the University of Pennsylvania Law School, where she was a Legal Research Fellow, and the University of California, Berkeley.

#### Non-State Employees or State Employees not Connected to the Garden State Network

Course Registration System through the My New Jersey portal. Setting up your account through the portal is a two-step process, the details of which are set forth in the next two paragraphs.

Once you receive the portal authorization code you will be prompted to go to the My New Jersey portal at <u>http://www.state.nj.us/</u> and create a portal account. Once your portal account is created you are prompted to enter your authorization code. This is Step 1 of the process, which you need only do once.

If you have already been issued an authorization code in the past you do not need to request another one. You can log into your account on the Garden State Network at http://www.state.nj.us and under the heading NJ L&PS Applications you will see the Attorney General's Advocacy Institute's Registration System. Click on that and log into your account on our system.

Upon setting up your portal account, you need to set up your AGAI Course Registration System account. This is Step 2. To do so, log on to the My New Jersey Portal <u>http://www.state.nj.us/</u>.
