Program Summary

This presentation will focus on the application of enhanced penalties for public officials convicted of certain corruption crimes and will discuss the Attorney General Guidelines Concerning Prosecutions of Public Officials.

Who Should Attend?

This program is intended for newly hired deputy attorneys general within the Division of Criminal Justice. The Division of Criminal Justice has selected those attorneys who must attend this program. Who Is the Faculty?

AAG Hoffman is a member of the Attorney General's Advocacy Institute faculty, and is a member of the National Attorneys General Training and Research Institute faculty. **Jennifer Kmieciak** has been a Deputy Attorney General in the Appellate Bureau since September 2011. She received her B.A. from The College of New Jersey and her law degree from the Rutgers School of Law - Camden. Following law school, she clerked in the Appellate Division for the Honorable Victor Ashrafi, J.A.D. She received an Attorney General Award for Excellence in 2012 for her trial assistance in State v. Abdur-Raheem, a murder case.

Non-State Employees or State Employees not Connected to the Garden State Network

If you are not a State employee, or are otherwise unable to access the AGAI Course Registration System through the Garden State Network, kindly email the Advocacy Institute at: <u>AdvocacyInstitute@lps.state.nj.us</u> for an authorization code to allow you access to the AGAI Course Registration System through the My New Jersey portal. **Setting up your account through the portal is a two-step process, the details of which are set forth in the next two paragraphs.**

Once you receive the portal authorization code you will be prompted to go to the My New Jersey portal at <u>http://www.state.nj.us/</u> and create a portal account. Once your portal account is created you are prompted to enter your authorization code. This is Step 1 of the process, which you need only do once.

If you have already been issued an authorization code in the past you do not need to request another one. You can log into your account on the Garden State Network at http://www.state.nj.us and under the heading NJ L&PS Applications you will see the Attorney General's Advocacy Institute's Registration System. Click on that and log into your account on our system.

Upon setting up your portal account, you need to set up your AGAI Course Registration System account. This is Step 2. To do so, log on to the My New Jersey Portal <u>http://www.state.nj.us/</u>. Upon opening the AGAI Course Registration System home page, you will see the Create Account link in the Login Box. Click on it and create your account, which will include you selecting a new user name and password.
