# LIBRARY WEEK 2015: SO, YOU THINK YOU KNOW THE FOURTH AMENDMENT? ARE YOU SURE?

## **Program Summary**

Brick-and-mortar law libraries aren't the only legal institutions that have changed dramatically in the face of new technologies. This presentation will start with a whirlwind tour of traditional search-and-seizure concepts, and then turn to technology-driven privacy issues that police, prosecutors, legislators, and judges are only just beginning to grapple with. We are facing a brave new world of search-and-seizure litigation. Are you ready? This fast-paced presentation will culminate with an interactive exercise involving a fact pattern that raises legal and policy issues that challenge our present understanding of the right to be free from unreasonable searches and seizures. Whether you consider yourself to be a Fourth Amendment expert or a rank novice, this presentation will make you think twice about what it means to have a "reasonable expectation of privacy" in a world filled with eye-in-the-sky "drones," smartphone cameras, automated license plate readers, and social media apps. And are "telephonic warrants" really a panacea? You probably won't find the answer to these questions through a LEXIS or WestLaw key word search. Some issues still need to be researched in the library. Join us there for a spirited conversation on where the Fourth Amendment may be heading.

## **State Employees**

## Non-State Employees or State Employees not Connected to the Garden State Network

If you are not a State employee, or are otherwise unable to access the AGAI Course Registration System through the Garden State Network, kindly email the Advocacy Institute at: AdvocacyInstitute@lps.state.nj.us for an authorization code to allow you access to the AGAI Course Registration System through the My New Jersey portal. Setting up your account through the portal is a two-step process, the details of which are set forth in the next two paragraphs.

Once you receive the portal authorization code you will be prompted to go to the My New Jersey portal at <a href="http://www.state.nj.us/">http://www.state.nj.us/</a> and create a portal account. Once your portal account is created you are prompted to enter your authorization code. This is Step 1 of the process, which you need only do once.

If you have already been issued an authorization code in the past you do not need to request another one. You can log into your account on the Garden State Network at http://www.state.nj.us and under the heading NJ L&PS Applications you will see the Attorney General's Advocacy Institute's Registration System. Click on that and log into your account on our system.

Upon setting up your portal account, you need to set up your AGAI Course Registration System account. This is Step 2. To do so, log on to the My New Jersey Portal <a href="http://www.state.nj.us/">http://www.state.nj.us/</a>. Upon opening the AGAI Course Registration System home page, you will see the Create Account link in the Login Box.
