# **Program Summary**

This course will provide an overview of the Victims of Crime Compensation Office, starting with its purpose and structure, including a discussion of the laws and regulations governing claim applications. The program will cover eligibility requirements, compensable crimes, compensable damages, catastrophic claims, subrogation, as well as common reasons for claim denial and appeals before the VCC Review Board.

# Who Is the Faculty?

AAG Alvin Ricardo Little, Esq. ("Rick", as he is known by several people) is the Executive Director of the New Jersey Attorney General's Victims of Crime Compensation Office

("VCCO"). In his role as Executive Director, Rick is responsible for the VCCO's final determinations on whether violent crime victims and secondary violent crime victims have presented claims which are eligible and compensable under New Jersey's Criminal Injuries Compensation Act of 1971.

Rick's career as a lawyer began in private practice at Kraft & Hughes, and continued at Riker, Danzig, Highland & Perretti. At each of those firms he focused primarily on public finance and secured transactions. Rick's public service career includes serving as Chief Regulatory Officer and an Assistant Commissioner at the New Jersey Department of Transportation and as the Executive Director of the New Jersey Transportation Trust Fund Authority.

Later, as a New Jersey Deputy Attorney General, Rick handled a variety of administrative agency cases, complex civil litigation, appellate cases, and complex transactional matters. He next served as the Assistant Attorney General in Charge of the Newark Administrative Practice Group. In 2016 he was appointed Deputy Director of the VCCO, and in 2017 Rick was named the VCCO's Executive Director. He is a graduate of the American University and the Catholic University Columbus School of Law.

Once you receive the portal authorization code you will be prompted to go to the My New Jersey portal at <a href="http://www.state.nj.us/">http://www.state.nj.us/</a> and create a portal account. Once your portal account is created you are prompted to enter your authorization code. This is Step 1 of the process, which you need only do once.

If you have already been issued an authorization code in the past you do not need to request another one. You can log into your account on the Garden State Network at http://www.state.nj.us and under the heading NJ L&PS Applications you will see the Attorney General's Advocacy Institute's Registration System. Click on that and log into your account on our system.

Upon setting up your portal account, you need to set up your AGAI Course Registration System account. This is Step 2. To do so, log on to the My New Jersey Portal <a href="http://www.state.nj.us/">http://www.state.nj.us/</a>. Upon opening the AGAI Course Registration System home page, you will see the Create Account link in the Login Box.
