Legal Considerations for Prosecuting the Drug-Impaired Driver 10:00 a.m. – 11:00 a.m.

This presentation will explore the Drug Recognition Expert Program, including the seven drug categories and the scope of testimony a DRE can provide. This presentation will also discuss the legal and practical issues involved in the prosecution of the drug-impaired driver, with a focus on challenges to the Drug Recognition Expert program and the current state of New Jersey law.

AP Monica do Outeiro is an Assistant Prosecutor in the Appellate Section of the Monmouth County Prosecutor's Office. AP do Outeiro began working for the Monmouth County Prosecutor's Office as a legal assistant in the Appellate Section and was sworn in as an Assistant Prosecutor in 2007. After brief stints in the Family Unit prosecuting juvenile and domestic violence cases, she returned to the Appellate Section. AP do Outeiro is the Municipal Prosecutors Supervisor and is responsible for developing case law involving the Alcotest. She is also a Police Training Commission Certified Instructor who regularly teaches at the Monmouth County Police Academy and at various in-service trainings for municipal police officers. AP do Outeiro graduated *magna cum laude* from Hamilton College in Clinton, New York in 2003 with a Bachelor of Arts degree in English Literature, and graduated *cum laude* from Quinnipiac University School of Law in Hamden, Connecticut in 2006.

DAG Robyn Mitchell is a Deputy Attorney General with the New Jersey Division of Criminal Justice. DAG Mitchell joined the Division in January 2000, working in the Legislation Section until 2003, and the Appellate Bureau from 2003 to 2011. Since March 2011, DAG Mitchell has been assigned to the Prosecutors Supervision & Training Bureau, where she handles DWI and Alcotest-related issues, provides legal guidance and support to assistant prosecutors and municipal prosecutors in the prosecution of DWI and traffic safety-related cases, provides DWI training to prosecutors, provides RADAR and speed-enforcement training to law enforcement officers, and serves as the Traffic Safety Resource Prosecutor for the State of New Jersey. DAG Mitchell started her career in 1991 as a staff attorney in the Criminal Defense Division of The Legal Aid Society in Manhattan. She received her B.A. degree in 1988 from Rutgers College and her J.D. in 1991 from the University of Maryland School of Law in Baltimore, Maryland.

Double Jeopardy in the Modern Era: Redefining Sameness 11:15 a.m. – 12:15 p.m.

In <u>State v. Rodney Miles</u>, the New Jersey Supreme Court recently redefined the contours of double-jeopardy jurisprudence under New Jersey law, establishing a new test for determining whether offenses are the same for purposes of the Double Jeopardy Clause. This presentation

will explore important double-jeopardy issues in the aftermath of <u>Miles</u> and also discuss related concepts involving joinder of offenses, joinder of defendants, severance of offenses, and severance of defendants.

**DAG Daniel I. Bornstein** has served as Chief of the Appellate Bureau of the Division of Criminal Justice since September 2014. He started working for the Appellate Bureau of the Division of Criminal Justice in 1995, and for about seven years, he handled both criminal trials and appeals while being simultaneously assigned to the Appellate Bureau and the Gangs & Organized Crime Bureau. While in the Gangs & Organized Crime Bureau, DAG Bornstein successfully prosecuted and tried cases involving homicide, racketeering, and weapons and narcotics offenses, including several multi-defendant wiretap cases. While in the Appellate Bureau, DAG Bornstein has handled many appeals before the New Jersey Supreme Court and the Appellate Division. He has also defended against habeas petitions before the United States District Court and Third Circuit Court of Appeals. He now supervises the Appellate Bureau and regularly provides guidance to prosecutors throughout the State. He is also an instructor for the Attorney General's Advocacy Institute. DAG Bornstein graduated *magna cum laude* from Colgate University and received his law degree from the University of Pennsylvania Law School. He clerked for the Honorable Martin J. Kole, J.A.D., t/a, and the Honorable Theodore A. Winard, J.S.C.

*Upcoming New Jersey Supreme Court Litigation* 1:15 p.m. – 2:45 p.m.

This course will provide a brief overview of the most significant criminal appeals likely to be argued in the New Jersey Supreme Court during the 2017-2018 Court Term.

AP Kelly Shelton is an Assistant Prosecutor with the Warren County Prosecutor's Office, which she joined in 1998. She has been assigned to various units within the office, including the Special Victim's Unit, the Trial Unit, and the Megan's Law Unit. Assistant Prosecutor Shelton began supervising the Mental Health Unit upon its establishment in 2009 and has been supervising the Appellate Unit since 2013. She is also an instructor for the Attorney General's Advocacy Institute. Prior to joining the prosecutor's office, she practiced civil litigation in Philadelphia, PA. Assistant Prosecutor Shelton graduated *magna cum laude* from Temple University School of Law in 1994.

**AP Douglas B. Pagenkopf** is an Assistant Prosecutor with the Gloucester County Prosecutor's Office, which he joined in 2016. He started in the Appeals Unit and currently serves on the trial team. Assistant Prosecutor Pagenkopf received his Juris Doctorate from Widener University School of Law – Delaware (now Delaware Law School) in 2015, where he served as Bluebook Editor for the Widener Law Review and as President of the Christian Legal Society. He received his Bachelor of Science degree in Biblical Studies from Abilene Christian University in 2001.

Everything You Need to Know About Jail Credit (But Were Afraid to Ask)

#### 3:00 p.m. - 4:00 p.m.

This program provides a guide to understanding jail credit. The course will clearly explain how jail credit is calculated, and the differences between jail credit, gap-time credit, and prior service credit. The Supreme Court jail credit cases in <u>Hernandez</u>, <u>Rawls</u>, <u>Joe</u>, and <u>C.H.</u> will also be discussed.

AAG Carol M. Henderson is a Deputy Chief of the Appellate Bureau of the Division of Criminal Justice and has been with the Bureau since 1979. She has briefed and argued over 60 cases before the New Jersey Supreme Court in addition to litigating cases before the Appellate Division, the United States District Court, and the Third Circuit Court of Appeals. AAG Henderson established a victim notification system for appellate cases which allows county victim witness offices to register cases where victims wished to be informed of appellate proceedings. AAG Henderson is an instructor for the Attorney General's Advocacy Institute, the New Jersey Bar Association and ICLE and has published articles on appellate practice, habeas litigation, interlocutory appeals, sentencing, legal writing, and prosecutor ethics and conduct. In 2008, she was the recipient of the New Jersey County Prosecutors' Association award for "Outstanding Advocacy Over a Career." AAG Henderson is the former chairperson of the Criminal Law Section and the Appellate Practices Committee of the New Jersey State Bar Association and a past president of the Women Lawyers' Caucus of Mercer County. AAG Henderson graduated with honors from Ramapo College of New Jersey and received her law degree from Seton Hall Law School.
