#### **Program Summary**

History, law and Jersey pride combine to tell the tale of the fight for sovereignty over Ellis Island. This program will chronicle the Ellis Island boundary dispute that started in 1829 and the series of cases that culminated in an unprecedented 1998 jurisdictional hearing before the United States Supreme Court. The result was both a testament to superlative lawyering and an affirmation of New Jersey resilience in the face of slings and arrows from New York attorneys and legislators, the federal bureaucracy and the Manhattan press corps.

#### Who Should Attend?

#### Who Is the Faculty?

**Robert A. Marshall, Esq.** is the Assistant Commissioner for Sustainability and Green Energy at the New Jersey Department of Environmental Protection. Bob previously worked in the Office of Counsel to the Governor for four Governors, most recently from January 2010 to February 2012. During his terms in Counsel's Office, he specialized in environmental and energy law and policy. Prior to and between terms of service, he was a Deputy Attorney General representing the Departments of Treasury and Environmental Protection from 1988 to 2010.

From 1995 through 1998, Bob Marshall was on special assignment in The Supreme Court of the United States in <u>State of New Jersey v. State of New York</u>, involving the jurisdictional dispute between the two states over Ellis Island. New Jersey prevailed in this litigation, where Marshall handled the direct and cross examination of the majority of witnesses during the six week trial, the first trial ever held in the Supreme Court building.

Marshall began his legal career in 1986, in the litigation department for the Philadelphia law firm of Montgomery, McCracken, Walker & Rhoads. Prior to that, Marshall served four Commissioners at DEP and spent evenings at Seton Hall School of Law, where he also served as the Editor (evening division) for the Seton Hall Legislative Journal.

Once you receive the portal authorization code you will be prompted to go to the My New Jersey portal at <a href="http://www.state.nj.us/">http://www.state.nj.us/</a> and create a portal account. Once your portal account is created you are prompted to enter your authorization code. This is Step 1 of the process, which you need only do once.

If you have already been issued an authorization code in the past you do not need to request another one. You can log into your account on the Garden State Network at http://www.state.nj.us and under the heading NJ L&PS Applications you will see the Attorney General's Advocacy Institute's Registration System. Click on that and log into your account on our system.
