#### **Program Summary**

This course will cover all forms of Electronic Surveillance typically encountered in an investigation from consensuals to wiretaps and everything in between. AAG Mayer will outline the statutory authority and legal standards to obtain them, the issues and pitfalls encountered when using them, and the value that these investigative tools can add to your case. She will also discuss CDW/Wiretap Affidavit writing "Dos" and "Don'ts" and provide practical advice about what she has learned from using various forms of electronic surveillance in her own cases or cases she has supervised over the years.

## Who Is the Faculty?

AAG Jill S. Mayer has been with the Division of Criminal Justice for 23 years. She is a Deputy Director, supervising the Gangs & Organized Crime Bureau and Specialized Crime Bureau. In addition to managing the Gangs/OC and Specialized Crimes Bureaus, AAG Mayer oversees the Attorney General's Shooting Response Team, the New Jersey State Police Witness Relocation Program, and is counsel to the Attorney General on matters involving electronic surveillance. Prior to becoming Deputy Director, AAG Mayer was Chief of the Specialized Crimes Bureau where she oversaw several units including the Atlantic City Violent Crimes Task Force, Motor Vehicle Commission, Labor Prosecutions, Interstate Theft, Environmental Crimes, ABC, Bias Crimes and Casino Prosecutions. Before becoming Bureau Chief of Specialized Crimes, AAG Mayer served in the Gangs, Organized Crime and Racketeering Bureau for 13 years, prosecuting several large-scale multi-defendant wiretap/racketeering cases and previous to that position, served in the Casino Prosecution Bureau for six years. She is on the faculty of the Attorney General's Advocacy Institute and has lectured on Cooperating Witnesses, Multi-Defendant Prosecutions, and Managing Up. AAG Mayer has been teaching Communications Data Warrants as member of the Top Gun Faculty since 2013 and also teaches Electronic Surveillance at DCJ's Academy at Sea Girt.

Before joining DCJ, AAG Mayer served as a law clerk to the Honorable Albert J. Garofolo, Presiding Judge, Superior Court, Criminal Division, in Atlantic County. She is a 1990 graduate of Dickinson College, Carlisle, Pennsylvania, with a B.A. in Political Science and is a 1994 graduate of Widener University School of Law, Delaware Campus.

## Non-State Employees or State Employees not Connected to the Garden State Network

Setting up your account through the portal is a two-step process, the details of which are set forth in the next two paragraphs.

Once you receive the portal authorization code you will be prompted to go to the My New Jersey portal at <a href="http://www.state.nj.us/">http://www.state.nj.us/</a> and create a portal account. Once your portal account is created you are prompted to enter your authorization code. This is Step 1 of the process, which you need only do once.

If you have already been issued an authorization code in the past you do not need to request another one. You can log into your account on the Garden State Network at http://www.state.nj.us and under the heading NJ L&PS Applications you will see the Attorney General's Advocacy Institute's Registration System. Click on that and log into your account on our system.

Upon setting up your portal account, you need to set up your AGAI Course Registration System account. This is Step 2.
