Program Summary

Cybercrime is now a part of virtually every criminal prosecution and digital evidence is incredibly useful and powerful evidence. This presentation will define cybercrime and explain why obtaining digital evidence is critical to the investigation and prosecution of a case. The program will also detail the steps of a forensic examination, demonstrate how to extract data from a computer and identify the various sources of data obtainable from a computer forensics examination. Tips will be provided for effectively presenting computer forensic evidence at trial and several common computer forensic topics will be discussed.

Who Should Attend?

This program is mandatory for all Division of Criminal Justice Deputy Attorneys General hired after January 1, 2015. The Division of Criminal Justice has notified those attorneys who are required to attend this program. Other attorneys within the Department of Law and Public Safety

are welcome to attend; space permitting. **Please do not attempt to register for this program if you are not an attorney in the Department of Law and Public Safety.**

Who Is the Faculty?

Lilianne Daniel is a Deputy Attorney General with the New Jersey Division of Criminal Justice. DAG Daniel joined the Division in October 2012 and currently serves in the Computer Analysis and Technology Unit (CATU) within the Financial & Computer Crimes Bureau. While in CATU, she has prosecuted and tried cases involving cyber fraud, online harassment, hacking, and child exploitation, including cases from the large-scale takedowns Operation Watchdog, Operation Ever Vigilant, Operation Predator Alert, Operation Safeguard, and Operation Safety Net. She has attended training on EnCase Computer Forensics in Dulles, VA, the NYPD Cybersecurity and Counterterrorism Conference, and the National Cyber Crimes Conference in Norwood, MA. Prior to CATU, DAG Daniel was assigned to the Specialized Crimes Bureau, where she prosecuted crimes involving the Motor Vehicle Commission and the Department of Labor. She also served in a mobility assignment as an Assistant Counsel in the Governor's Office from May 2017 through January 2018, where she was responsible for liaising with the State's criminal justice agencies and reviewing applications for executive clemency. DAG Daniel received her bachelor's degree *magna cum laude* from The College of New Jersey and her law degree from Seton Hall University School of Law. She was a law clerk in the 2011-2012 court term for the Honorable Stephen B. Rubin, J.S.C., in Hunterdon County (retired).

Brandy Malfitano is a Deputy Attorney General with the New Jersey Division of Criminal Justice. DAG Malfitano joined the Division in May 2013 and currently serves in the Financial and Computer Crimes Bureau, where she has prosecuted and tried cases involving cell phone tracing, hacking, cyber extortion, child exploitation, theft offenses, money laundering, terrorism, and computer intrusions. She has attended training at the NYPD Cybersecurity and Counterterrorism Conference and the High Tech Crimes Investigators Association conference. Prior to being assigned to the Financial and Computer Crimes Bureau, DAG Malfitano served in the Gangs and Organized Crimes Bureau where she prosecuted and tried cases involving racketeering, attempted murder, aggravated assault, drug and gun trafficking, money laundering, securities fraud, and human trafficking. Before joining the Division, she was an associate with a prominent criminal defense firm in Bergen County, NJ. She also served as a Law Clerk for the Honorable Severiano Lisboa, III, J.S.C. (*retired*), in the Hudson County Superior Court. DAG Malfitano obtained her undergraduate degree from Drexel University in 2004, and her law degree from Rutgers Law School (Newark) in 2009. She is currently a Barrister at the C. Willard Heckel Inn of Court.

Non-State Employees or State Employees not Connected to the Garden State Network

If you are not a State employee, or are otherwise unable to access the AGAI Course Registration System through the Garden State Network, kindly email the Advocacy Institute at: njagai@njoag.gov for an authorization code to allow you access to the AGAI Course Registration System through the My New Jersey portal. **Setting up your account through the portal is a two-step process, the details of which are set forth in the next two paragraphs.**

Once you receive the portal authorization code you will be prompted to go to the My New Jersey portal at <http://www.state.nj.us/> and create a portal account. Once your portal account is created you are prompted to enter your authorization code. This is Step 1 of the process, which you need only do once.

If you have already been issued an authorization code in the past you do not need to request another one. You can log into your account on the Garden State Network at <http://www.state.nj.us> and under the heading NJ L&PS Applications you will see the Attorney General's Advocacy Institute's Registration System. Click on that and log into your account on our system.

Upon setting up your portal account, you need to set up your AGAI Course Registration System account. This is Step 2. To do so, log on to the My New Jersey Portal <http://www.state.nj.us/>.
