Trial work requires knowledge of the New Jersey Rules of Evidence, the application of the rules and interplay with the Rules of Court. This presentation will help you enhance your trial skills with the evidence rules you need to know for your next civil trial.

Who Is the Faculty?

AAG Kevin Jespersen is Chief Counsel to the Attorney General. He also serves as Acting Director of the Division of Consumer Affairs. Kevin has been with OAG since 2016, serving previously as Chief Counsel and later as Executive Assistant Attorney General. Kevin joined the Division of Law in 2004 as a Deputy Attorney General, rising to Assistant Chief of the Professional Boards Prosecution Section, Assistant Attorney General in Charge of the Affirmative Civil Enforcement Practice Group, and the Division's Deputy Director. He is certified by the Supreme Court of New Jersey as a Civil Trial Attorney and has held that designation since 1997. Kevin has handled hundreds of cases throughout his career, and has tried to verdict more than 40 cases, including matters before the state and federal courts in New Jersey and New Jersey administrative agencies. He has argued more than 40 appeals, including in the New Jersey Supreme Court and the U.S. Court of Appeals for the Third Circuit. Between 1981 and 2004, he worked in private practice, including at Slattery & Jespersen, which he co-founded in 1996. He graduated from Rutgers University and the New York University School of Law.

DAG Noreen Kemether is currently the Section Chief of the Employment Litigation Section of the Division of Law. She is a 1983 graduate of Villanova University, received an MBA from Drexel University in 1986 and her JD from Widener University School of Law in 1991. Prior to joining the Division of Law, Noreen was in private practice for fifteen years specializing in medical malpractice defense litigation. She has extensive civil trial experience, trying over sixty jury trials. Noreen has been a high school and college basketball official for 33 years and played basketball with a full scholarship in college.
