Program Summary

This presentation will focus on cyberbullying and related conduct, as well as on applicable criminal charges. Often conduct that begins as consensual can be used to bully, stalk, harass, or extort a victim. Learn about risky online behaviors and the legal tools available to address them.

Who Is the Faculty?

Julia Glass is the Deputy Chief of the Cyber Unit of the Financial and Computer Crimes Bureau at the New Jersey Division of Criminal Justice, where she supervises Deputy Attorneys General prosecuting child exploitation, computer crimes, and cyber crimes. She became a Deputy Attorney General in 2008 and spent eight years assigned to the Gangs and Organized Crimes Bureau, where she prosecuted drug and weapons trafficking organizations and oversaw all manner of electronic surveillance and wiretap investigations. Prior to joining DCJ, Julia was an associate at Ballard Spahr, LLP in Philadelphia, and clerked for the Honorable Theodore A.

McKee, United States Court of Appeals for the Third Circuit, and the Honorable Harvey Bartle III, United States District Court for the Eastern District of Pennsylvania. She is a graduate of the Temple University School of Law and the University of Colorado.

Detective Joseph Santamaria is currently assigned to the Digital Technology Investigations Unit (DTIU) based out of the New Jersey State Police Hamilton Technology Complex and is a member of the New Jersey Internet Crimes Against Children (ICAC) Task Force. He has been a Trooper since December 10th, 2004, after graduating from the New Jersey State Police Academy as part of the 138th Class. As a detective in the DTIU, Detective Santamaria conducts both reactive and proactive investigations regarding the exploitation of children. He has received specialized training that aids him in his investigations of child exploitation, including training for forensics tools such as EnCase Computer Forensics, Cellebrite and XRY. In addition to his investigations, Detective Santamaria is the Internet Safety Program Lead Coordinator for the New Jersey State Police and he, along with his colleagues, conduct numerous Internet Safety presentations throughout the state for schools, churches, and other organizations and groups.

portal at <u>http://www.state.nj.us/</u> and create a portal account. Once your portal account is created you are prompted to enter your authorization code. This is Step 1 of the process, which you need only do once.

If you have already been issued an authorization code in the past you do not need to request another one. You can log into your account on the Garden State Network at http://www.state.nj.us and under the heading NJ L&PS Applications you will see the Attorney General's Advocacy Institute's Registration System. Click on that and log into your account on our system.
