# **Program Summary**

This program will provide assistant prosecutors and law enforcement personnel with an advanced understanding of domestic violence and the dynamics that make up this crime. The training will include an in-depth review of established best practices for investigating domestic violence cases, including addressing officer safety concerns and implementing safety protocols when responding to DV calls. The course will also cover understanding how cultural identities affect domestic violence and police response, why domestic violence victims may remain in abusive relationships or return to their abusers and how to best support victims and provide them with resources throughout the legal process. Upon completion of the program, attendees will be able to identify domestic violence and lethality indicators, practice strategies for maintaining safety when responding to domestic violence calls, demonstrate victim-centered domestic violence investigation approaches, and work more effectively with victims of domestic violence from a variety of cultures, religions, sexual orientations, races/ethnicities, and disability statuses.

### Who Should Attend?

This program is only open to assistant prosecutors and law enforcement officers. Please do not attempt to register for this program if you are not an assistant prosecutor or law enforcement officer.

## Who Is the Faculty?

**Sonja Furlow** is a career Assistant Prosecutor in the Camden County Prosecutor's Office. She is currently Section Chief of the Domestic Violence Unit, which investigates and prosecutes all cases involving acts of domestic violence. Furlow previously served as Section Chief of the Community Partnership & Prosecutions Unit and Deputy Section Chief of the Trial Team Unit and has also worked in the Motions & Appeals, Juvenile, Grand Jury, Trial Team and Special Prosecutions units. Since joining the Camden County Prosecutor's Office in 1998, Furlow has prosecuted cases involving assault, robbery, burglary, eluding, official misconduct and murder.

**Dennis Richards** is a Detective in the Gloucester Township Police Department. In 2015, he was assigned to a newly created position of Domestic Violence Detective. He and one other detective oversee all DV cases, including victim and defendant follow up, departmental DV training, and community outreach pertaining to Domestic Violence. Richards has been a member of the Special Response Team (SWAT) since 2011 and has also served as an FTO, academy instructor, and shift investigator. He was previously a patrolman, special police officer and State and county corrections officer.
