#### ***Program Summary***

This presentation will discuss the investigative steps and legal processes needed to obtain forensic evidence for a child pornography case. The presentation will also cover how to present digital evidence in court and review potential pitfalls and defenses. It will conclude with a legal review of the new enhanced penalties applicable in child pornography prosecutions.

#### ***Who Is the Faculty?***

**DAG Jillian Carpenter** is a Deputy Bureau Chief in the Financial & Computer Crimes Bureau of the New Jersey Division of Criminal Justice, where she primarily oversees the Cyber Unit. Before rejoining Financial and Computer Crimes, DAG Carpenter served as the Assistant Bureau Chief in the Office of the Insurance Fraud Prosecutor Private Insurance Section. In her initial assignment to the Financial & Computer Crimes Bureau, DAG Carpenter prosecuted a variety of white collar and computer related crimes including money laundering, commercial bribery, and endangering the welfare of children by manufacturing, distributing, and possessing child pornography. Prior to joining DCJ, DAG Carpenter worked for a private firm in Trenton, New Jersey representing clients in general litigation and criminal defense. DAG Carpenter began her

legal career in the Mercer County Superior Court - Criminal Division as a law clerk for the Honorable Judges Charles A. Delehey, Thomas P. Kelly, and Robert C. Billmeier. Prior to practicing law, DAG Carpenter worked at the Rhode Island Child Advocacy Center and Providence Police Department Special Victims Unit.

**DAG Lillianne Daniel** serves in the Division of Criminal Justice's Cyber Unit within the Financial & Computer Crimes Bureau. She has prosecuted and tried cases involving cyber fraud, online harassment, hacking, and child exploitation. Most recently, she served as the lead attorney for Operation Open House, the Division's first proactive undercover chat operation in conjunction with the New Jersey Internet Crimes Against Children Task Force. She has attended trainings through the National Computer Forensics Institute and EnCase Computer Forensics, and is certified in Child First/Finding Words protocol for forensic interviewing of child victims. Prior to joining the Cyber Unit, DAG Daniel was assigned to the Specialized Crimes Bureau, where she prosecuted crimes involving the Motor Vehicle Commission and the Department of Labor. She also served on mobility assignment as an Assistant Counsel in the Governor's Office from May 2017 through January 2018, acting as a liaison with State criminal justice agencies and reviewing applications for executive clemency. DAG Daniel was a law clerk for the Honorable Stephen B. Rubin, J.S.C., in Hunterdon County (retired). She received her bachelor's degree *magna cum laude* from the College of New Jersey and her law degree from Seton Hall University School of Law.

**Lieutenant John Pizzuro** is a member of the New Jersey State Police and is the Commander for the New Jersey Internet Crimes Against Children Task Force. Lt. Pizzuro has both investigated and led large teams that conducted complex investigations of internet crimes, fraud involving non-profit and financial institutions, bribery, corruption, money laundering, tax evasion, bank robbery, organized crime, racketeering, homicide, terrorism and international narcotics and human trafficking. Lt. Pizzuro holds a M.A. in Human Resources Development and Training. He is a certified as a Master Neuro Linguistic Practitioner and is also a Certified Fraud Examiner. Lt. Pizzuro is a frequent teacher and lecturer on subjects that include personal development, communication skills, wellness for law enforcement officers, leadership, cognitive interviewing and communication, the impact of stress on the law enforcement community, vicarious trauma and the impact of social media and apps on children.
