### **Program Summary**

This basic course in appellate writing and procedure will provide DCF deputies with a primer on the Division of Law's policies and expectations for handling appeals. The program will focus on brief writing, including properly formatting appellate briefs and identifying facts that are material and relevant to the issues on appeal. The Appellate Practice Group protocol for appellate brief review will be detailed, and the paramount importance of adhering to timely filing requirements and the consequences for failing to do so will be discussed.
