Program Summary

This presentation will provide information on the various programs available to adolescents in the custody of DCPP, including independent living, life skills, Medicaid extension for young adults, after care, wrap around services and NJ Scholars. A breakdown of the financial assistance available to adolescents will be discussed, including a hierarchy of the sources of these funds. This information will assist deputies in matters involving adolescents since other parties often make requests of the court to order financial assistance/services.

Who Is the Faculty?

Ms. Puryear assists with the coordination of programs, services, and initiatives for the adolescent and young adult population across the Department, in partnership with external stakeholders and young people with lived child welfare experience. Ms. Puryear provides supervisory support to the office to ensure that organizational and program outcomes are met, including program development, data collection and analysis to measure and sustain program effectiveness. She holds a bachelor's degree in social work from Temple University and a master's degree in social work from Rutgers University.
