Program Summary

This program will provide a primer on how to litigate cases encountered in the Health and Human Services Section of the Division of Law. The course will include a discussion of OAL cases from assignment to the Final Agency Decision and instruction on motion practice in the Superior and Federal courts.

Who Should Attend?

Attendance at this program is limited to Deputy Attorneys General in the Division of Law's Health and Human Services Section and Assistant Attorneys General in the Trenton Administrative Practice Group.

Who Is the Faculty?

DAG Gregory J. Sullivan is a member of the Health & Human Services Section of the Division of Law. The cases he handles for the Human Services and Health Departments include Medicaid matters, Special Needs Trusts, Guardianships, enforcement actions involving penalty matters against health care providers, license certification, denials and revocations, and civil rights matters. He was previously a deputy in the Tort Litigation & Judiciary Section. Before coming to the DOL,

he was an associate and then a partner in a Mercer County law firm for two decades. Greg graduated from Seton Hall Law School and clerked for the Hon. Samuel D. Lenox, Jr., A.J.S.C.

DAG Christopher Riggs is a member of the Health & Human Services Section of the Division of Law. The cases he handles for the Human Services and Health Departments include Medicaid matters, Special Needs Trusts, Guardianships, enforcement actions involving penalty matters against health care providers, license certification, denials and revocations, and civil rights matters. He was previously a deputy in the Tort Litigation & Judiciary Section. Chris has handled all aspects of civil litigation. He defended the constitutionality of requiring the use of non-monetary bail in lieu of monetary bail under the Criminal Justice Reform Act, a position vindicated in the precedential Holland v. Rosen, 895 F.3d 272 (3d Cir.), cert. denied, 139 S.Ct. 440 (2018). Chris clerked for the Hon. Jean B. McMaster, J.S.C. and holds a J.D. from the Florida Coastal School of Law.
