### **Program Summary**

This presentation and panel discussion will review the components of how a bill becomes a law in New Jersey and identify the key players in the legislative process. The panelists will discuss significant legislative measures enacted into law to illustrate how the process works and examine the roles of the players who are involved.

## Who Is the Faculty?

**AAG B. Stephan Finkel** is the Director of Legislative Affairs for the Attorney General. He has supervised the Legislative Affairs Unit during the tenure of twelve prior Attorneys General. AAG Finkel has worked on bills and initiatives on subjects critical to the mission and operation of the Department, including human trafficking, insurance fraud, sex offenders, domestic violence, child pornography, prisoner reentry, juvenile justice, firearms, internet safety, bail reform, consumer protection, civil rights, official corruption and election reform. AAG Finkel previously served in the Division of Law in the JUA Litigation/Insurance Section. He received his law degree from

Villanova University School of Law, graduating *cum laude* and holds a B.A. in psychology from Franklin and Marshall College.

Robert Garrenger, Esq. is the Governor's Senior Special Counsel – Finance. Mr. Garrenger serves as a member of the Governor's budget team and oversees the legal sufficiency of the structure and contents of the annual State budget. Mr. Garrenger has served in various legal positions in the Office of the Governor, including Senior Associate Counsel, Deputy Chief Counsel, Assistant Counsel, and Special Budget Counsel. Mr. Garrenger commenced his State service as a Deputy Attorney General in the New Jersey Department of Law and Public Safety. As a DAG, Mr. Garrenger represented the State of New Jersey and various State officials, including the Governor and the State Treasurer, in a variety of civil litigation. Prior to his service in Stategovernment, Mr. Garrenger worked as an associate in the Washington, D.C. firm of Sutherland, Asbill & Brennan, LLP, and served as a law clerk to the Honorable John C. Lifland of the United States District Court for the District of New Jersey. Mr. Garrenger received his Bachelor of Arts degree, cum laude, from Yale University, and earned his Juris Doctor degree, cum laude, from the University of Michigan Law School.

**Kate McDonnell, Esq.** is Deputy Chief Counsel to Governor Philip D. Murphy. She previously served as General Counsel to the Assembly Majority Office for eight years. Prior to becoming General Counsel, she was an Associate General Counsel in the Assembly Majority Office, where she worked in a variety of policy areas. McDonnell is a magna cum laude graduate of the University of Notre Dame and holds both a J.D. from the Rutgers School of Law, Camden and a Master's Degree from Rutgers New Brunswick's Bloustein School of Policy and Planning.

**AAG Amy E. Melick** is a member of the Attorney General's Legislative Affairs Staff, where she handles a broad array of matters related to the Department's mission. Prior to joining the Department, AAG Melick worked in the Office of Legislative Services. She has also served on mobility assignment as Deputy Chief Counsel in the Office of the Governor.
