Program Summary

This course is designed to prepare deputies for their election day duties. They will learn about the work of their clients (county election officials), the legal and non-legal issues they are likely to encounter, and their roles as both counselor and advocate.

Who Is the Faculty?

DAG Susan Scott is the Section Chief of the Community Affairs, State and Elections Section of the Division of Law. She is a graduate of Rutgers University and the University of New Hampshire School of Law.

SDAG George Cohen is a member of the Community Affairs, State and Elections Section of the Division of Law. He has provided legal guidance to a host of State agency clients, including years of hands-on experience with New Jersey's election laws. SDAG Cohen has handled sensitive election law cases addressing the adequacy of electronic voting machines, an attack on statutory voter registration deadlines and a constitutional challenge to residency and registration requirements for persons circulating nominating petitions. He holds a B.A. from the University of Pennsylvania and a J.D. from the Benjamin N. Cardozo School of Law of Yeshiva University.
