Program Summary

This program will provide a basic overview of energy law and policy. The program will discuss the regulatory framework governing electric and gas generation, transmission and distribution. It will also briefly discuss the oversight and regulation of renewable energy, energy efficiency and demand response.

Who Should Attend?

Who Is the Faculty?

Stefanie A. Brand is the Director for the Division of Rate Counsel, a position she has held since October 1, 2007. The Division of Rate Counsel represents the interests of consumers of regulated electric, natural gas, water/sewer, telecommunications, cable TV service, and insurance (residential, small business, commercial and industrial customers). Prior to joining the Division of Rate Counsel, Stefanie was the Assistant Attorney General in Charge of Litigation for the Division of Law in the Department of Law and Public Safety. In that position, she oversaw all civil litigation for the State. Her tenure with the Division of Law as an assistant and deputy attorney general included work in the areas of federal litigation, child welfare, environmental regulation, human services, employment and tort law. Stefanie was in private practice before joining the Division of Law. Stefanie graduated from Columbia University School of Law and clerked for Associate

Justice Gary Stein of the New Jersey Supreme Court.

Kenneth J. Sheehan, Esq. is the Business Ombudsman for the New Jersey Board of Public Utilities (NJBPU). Mr. Sheehan previously worked in both the public and private sectors as Section Chief of the Public Utilities Section of the Division of Law, in senior staff positions at the NJBPU, and at a high tech startup. Mr. Sheehan served as a law clerk to the Hon. Arthur D'Italia, Hudson County Assignment Judge. He is a graduate of St. Peter's College and Rutgers - Newark School of Law, where he was the Articles Editor of the *Rutgers Law Review*.

Non-State Employees or State Employees not Connected to the Garden State Network

If you are not a State employee, or are otherwise unable to access the AGAI Course Registration System through the Garden State Network, kindly email the Advocacy Institute at: njagai@njoag.gov for an authorization code to allow you access to the AGAI Course Registration System through the My New Jersey portal. **Setting up your account through the portal is a two-step process, the details of which are set forth in the next two paragraphs.**

Once you receive the portal authorization code you will be prompted to go to the My New Jersey portal at <http://www.state.nj.us/> and create a portal account. Once your portal account is created you are prompted to enter your authorization code. This is Step 1 of the process, which you need only do once.

If you have already been issued an authorization code in the past you do not need to request another one. You can log into your account on the Garden State Network at <http://www.state.nj.us> and under the heading NJ L&PS Applications you will see the Attorney General's Advocacy

Institute's Registration System. Click on that and log into your account on our system.

Upon setting up your portal account, you need to set up your AGAI Course Registration System account. This is Step 2. To do so, log on to the My New Jersey Portal <http://www.state.nj.us/>. Upon opening the AGAI Course Registration System home page, you will see the Create Account link in the Login Box.
