This program will provide attorney managers with a range of leadership techniques that will enable them to work more effectively with colleagues, direct reports and adversaries. Situational leadership encourages setting performance goals, providing employee feedback and coaching, and encouraging proactive problem solving. Applying these techniques in a legal setting will expand employees' skills, improve the efficiency of case management and workflow and create attorney managers who are accessible and approachable.
