## **Program Summary**

Homeland security and preparedness extends well beyond the motto "If You See Something, Say Something". This program will examine the authorities used to construct homeland security programs nationally and within New Jersey, with a focus on New Jersey's homeland security entities and their partnership with federal agencies. The presenter will also discuss homeland security programs, investigations and prosecutions.

### Who Should Attend?

This program is open to all government attorneys, space allowing.

### Who Is the Faculty?

Eric Tysarczyk, Esq. is the Director of Preparedness for New Jersey's Office of Homeland Security and Preparedness. He oversees the office's enterprise risk management programs, including the convergence of cyber and physical security, public and private sector security preparedness, and infrastructure protection. Mr. Tysarczyk is a Senior Fellow with Auburn University's Center for Cyber and Homeland Security, a nonpartisan think tank that develops innovative strategies to address current and emerging security threats to the United States. He is

also a member of the federal Classified National Security Information Program's Policy Advisory Committee.

Prior to joining OHSP, Mr. Tysarczyk served as Director of Preparedness Policy at the White House Homeland Security Council, where he organized policy initiatives and programs that supported homeland security efforts across the nation. He was also the Director for Intergovernmental Programs at the U.S. Department of Homeland Security, where he oversaw and coordinated programs for state and local governments, including assessing the resources they needed to combat terrorism and assisting local homeland security efforts. Mr. Tysarczyk was Deputy Chief Counsel for the Pennsylvania Emergency Management Agency and the Office of the State Fire Commissioner, where he provided legal advice on the governor's state of emergency declarations, worked with incident response authorities, and on emerging issues in communication technologies.

In addition to his government service, Mr. Tysarczyk has held positions with a number of private sector organizations, including serving as a principal in a small consulting company that provided services to private sector and governmental organizations, including the U.S. Department of Defense. As a consultant for PricewaterhouseCoopers, Mr. Tysarczyk assisted commercial clients with operations analysis, technology integration, and enterprise risk management, including prescient strategies to address cybersecurity. After PwC, Mr. Tysarczyk joined a NASDAQ-traded organization and focused his work on business analytics and cybersecurity, including risk management strategies for international supply chains.

Mr. Tysarczyk earned a Bachelor of Science degree in Computer Science from Arcadia University and a Juris Doctor from The Catholic University of America.

Click on it and create your account, which will include you selecting a user name and password. Once you create your account, you can access the AGAI Course Registration System at http://reg2.dcj.lps.state.nj.us/lpcreg/login.aspx?portalid=2 to register for future courses or to manage your account. # Non-State Employees or State Employees not Connected to the Garden State Network

If you are not a State employee, or are otherwise unable to access the AGAI Course Registration System through the Garden State Network, kindly email the Advocacy Institute at: <a href="mailto:njagai@njoag.gov">njagai@njoag.gov</a> for an authorization code to allow you access to the AGAI Course Registration System through the My New Jersey portal. Setting up your account through the portal is a two-step process, the details of which are set forth in the next two paragraphs.

Once you receive the portal authorization code you will be prompted to go to the My New Jersey portal at <a href="http://www.state.nj.us/">http://www.state.nj.us/</a> and create a portal account. Once your portal account is created you are prompted to enter your authorization code. This is Step 1 of the process, which you need only do once.

If you have already been issued an authorization code in the past you do not need to request another one. You can log into your account on the Garden State Network at http://www.state.nj.us and under the heading NJ L&PS Applications you will see the Attorney General's Advocacy Institute's Registration System. Click on that and log into your account on our system.

Upon setting up your portal account, you need to set up your AGAI Course Registration System account. This is Step 2. To do so, log on to the My New Jersey Portal <a href="http://www.state.nj.us/">http://www.state.nj.us/</a>. Upon opening the AGAI Course Registration System home page, you will see the Create Account link in the Login Box.
