# **Program Summary**

This program will cover the mediation process for SPEC and Tort cases from start to finish, including logistics, strategies and practical pointers to help deputies achieve successful outcomes.

#### **Eligibility**

## **Faculty**

**DAG James M. Duttera** is an Assistant Section Chief in the State Police, Employment Litigation & Corrections Section of the Division of Law, where he manages a group of trial attorneys and handles the defense of complex employment litigation and civil rights cases brought against State entities. DAG Duttera's extensive litigation experience includes handling all aspects of civil matters from inception through appeal and trying multiple cases before the New Jersey Superior and United States District Courts. Prior to joining the Division of Law, DAG Duttera served as a trial lawyer working exclusively in employment litigation for over a decade. DAG Duttera is a graduate of St. Joseph's University and holds a J.D. from Temple University Beasley School of Law.

**DAG Brian Hunkins** is a member of the Tort Litigation & Judiciary Section of the Division of Law. He prepares tort cases for trial, including conducting investigations, answering interrogatories, preparing witnesses for depositions, deposing opposing witnesses, consulting experts, deposing experts, and drafting dispositive motions. Before joining the Division, DAG Hunkins was a defense litigator for 28 years, primarily concentrating in medical malpractice defense. He tried 28 cases to verdict.
