## **Program Summary**

This program will enhance attorneys' legal research skills by introducing them to the unique services and resources available through the New Jersey State Library Information Center. The presenters will cover accessing premium database content, borrowing print and eBooks, requesting interlibrary loan materials and other resources to assist government attorneys' legal research. The instructors will supplement their lecture with a live demonstration of several library services and provide an opportunity for students to ask research questions.

#### Eligibility

This program is open to attorneys in the Department of Law and Public Safety and county prosecutors' offices. Registrants will receive the course materials prior to the program date.

#### **Faculty**

Maria Baratta is the Associate Director of the State Library Information Center (SLIC), where she manages the library's reference services. Ms. Baratta previously served as Library Manager of the New Jersey Department of Environmental Protection's Information Resource Center and as the Chief of Research Services with the New Jersey Attorney General's Library. Ms. Baratta was also an Associate Director of the New Jersey State Library Talking Book & Braille Center, where she oversaw readers' advisory, circulation and equipment management and the Collection Management Director at the Bucks County Free Library in Doylestown, PA, where she supervised

the selection and technical processing of print and e-book collections, interlibrary loan and online database services. She earned her bachelor's degree from Lafayette College, Easton, PA, and her Master's in Library Science from Kutztown University, Kutztown, PA and holds professional librarian certificates in New Jersey and Pennsylvania.

**Leslie Witko** is the Supervising Librarian of the New Jersey State Law Library. She was previously a senior attorney for Legal Services of New Jersey and clerked in the New Jersey Superior Court - Criminal Division. Ms. Witko holds a B.A. from the State University of New York at Purchase, an M.L.I.S from Rutgers University School of Communication and Information and a J.D. from Pace University School of Law.
